#### **GENERAL ELIGIBILITY CONDITIONS:** 3.2.1

(a) The Bidder can be

A body corporate incorporated in India under the Companies Act, 1956 or 2013. Or

A Limited Liability Partnership Firm (LLP) registered under section 12 of Limited Liability Partnership Act, 2008.

Or Partnership firm, registered under Partnership Act'1932

Or

Registered Proprietorship Firm.

Or

Joint Venture of two entities.

Or

Bidding Consortium or Consortium (Max. 2 members i.e. One Lead Member and one Consortium Members) (Agreement format attached in NIT)

- (b) The bidder must be:
  - An Indian Firm and Should be in existence for at least 3 years from last date of submission of bid.
  - Should have a registered number of GST, TAN, PAN Number etc.
- (c) In case a bid is submitted by consortium, consortium should not consist of more than two members (including the Lead Bidder) and shall be formed under a duly stamped consortium agreement. The original stamped consortium agreement shall be submitted along with the Bid Document. No bidder, sole or a member of the consortium, can bid separately as a sole bidder or as part of any other consortium. This is applicable to any company where sole bidder/consortium member has majority shareholding. The list of Consortium Members needs to be declared in the bid which cannot be changed by the bidder later on. 



#### 3. Scope of Works:

The detailed scope of works under this contract shall be referred at Section VI: SCOPE OF WORK & TECHNICAL SPECIFICATIONS.

#### 4. **Exemptions for MSEs:**`

- 4.1 Exemptions for Indian MSEs Bidders / Manufacturers who are registered under NSIC / Udyog Aadhaar Category only are provided as per Govt. Rules.

Liquidated damages in the event of delay in affecting the supply and I&C within agreed period, a reduction in the price shall be levied @ 0.50% of the total Work order value per week or part thereof subject to maximum of 3 % of the total Work order value.

## 20.2 Liquidated Damage during O&M :

Liquidated damages in the event of replacement of the defective/ non-glowing Solar LED lights within 48 hours of its failure coming into knowledge of the Contractor through any means. Penalty for non-fulfillment after 48hours is reckoned as follows.



#### 1. Scope of work & Technical Specifications :

A standalone solar photovoltaic street lighting system (SLS) is an outdoor lighting unit used for illuminating a street or an open area. The Solar Street Lighting System consists of solar photovoltaic (SPV) module, a luminaire, storage battery, control electronics, inter-connecting wires/cables, module mounting pole including hardware and battery box. The luminaire is based on White Light Emitting Diode (W-LED), a solid state device which emits light when electric current passes through it. The luminaire is mounted on the pole at a suitable angle to maximize illumination on the ground. 




