4. But the tender can only be submitted after uploading the mandatory scanned documents as per list given below.

As per the orders of Ministry of Finance, Govt of India, dated 12.12.20, firms are exempted from depositing earnest money with the tender, however tenderers have to submit a "bid security declaration" stating that if they withdraw or modify their bids, during period of validity etc, they will be suspended for the time specified in the tender documents.
