ORDER

1. The present Petition has been filed by the Petitioner seeking that the Respondent DGVCL to pay an amount of Rs. 7,96,058/- towards sale of excess units of Wind Farm for the months of April-2020 arising on account of rejection of sale of excess units of wind farm generation for the month of April by DGVCL due to grant of

STOA, though the Petitioner Oriilon India Pvt. Limited has not purchased any units from Open Access.

2. During the virtual hearing of this Petition held on 14.12.2021 @ 12:30 hrs., the Petitioner is represented by Mr. Nitin Patil whereas; Mr. B. K. Patel, Add. Chief Engineer, DGVCL and Mr. S. P. Patel, SE (Comm.), DGVCL are present on behalf of the Respondent DGVCL.
3. Heard Mr. Nitin Patil appearing for the Petitioner, who submitted that the Petitioner is now not willing to pursue the present matter and desires to withdraw the same unconditionally since the Respondent DGVCL agreed to pay the said amount and hence the matter is now amicably resolved. Moreover, the Respondent DGVCL has also refunded the amount to the Petitioner which was earlier rejected. Therefore, no relief or any further action remains in the present matter. Mr. Nitin Patil further reaffirmed that an affidavit for withdrawal of the present Petition has been already filed by the Petitioner on 03.12.2021 before the Commission and accordingly, the Commission may allow the Petitioner to withdraw the Petition unconditionally.
4. We note that Mr. Nitin Patil submitted that an affidavit seeking withdrawal of present Petition is already filed on 03.12.2021 before the Commission and now the Petitioner does not want to pursue the matter since the relief sought in the Petition is now resolved amicably between the parties and requested for unconditionally withdrawal of the Petition. Taking on record the above statement of the Petitioner, this Petition stands disposed of as withdrawn unconditionally.
5. We order accordingly.
