Petitioner North Bihar Power Distribution Company Limited (NBPDCCL) is represented by Mr Deepak Kumar, Chief Engineer(Comm.), Mr Sujeet Kumar, Accounts Officer, Ms. Manju Kumari, AEE alongwith their consultants.</p> <ul style="list-style-type: none"> <li>➤ NBPDCCL has submitted its tariff petition for True up of FY 2020-21, APR of FY 2021-22 and ARR of FY 2022-23 to FY 2024-25 and determination of tariff for FY 2022-23 vide its letter no. 515 dated 15.11.2021.</li> <li>➤ The petition was examined and accordingly, the petition was listed today for admission. Petitioner advanced oral arguments and also gave power point presentation.</li> <li>➤ Commission perused the instant petition and directs the petitioner to submit the additional information/clarification within the time frame as decided by the Commission which shall be communicated by separate letter of the Commission. Accordingly, Commission admits the petition.</li> <li>➤ An abridged form of the petition is approved for public notice and shall be published in the Newspaper by the petitioner for inviting comments/suggestion/objections from all stakeholders and general public.</li> <li>➤ The Commission directs the petitioner NBPDCCL to issue a Public Notice in abridged form of the petition in at least two daily newspaper one in English and the other in Hindi (Hindi Version to be translated by the NBPDCCL) on or before <b>23.12.2021</b> in font size of 10-12, having wide circulation in all districts in the State of Bihar inviting objections/suggestions from the consumers, stakeholders and general public.</li> <li>➤ The notice shall be repeated after four (4) days from the date of its first publication in two different daily newspaper one in English and the other in Hindi. The newspaper clippings may be submitted to the Commission within three days of its publication.</li> <li>➤ As a matter of precaution, before it is published, the figures and the contents of the ARR and public notice shall be checked by the NBPDCCL. The complete tariff petition along with annexure, all the additional information/data submitted and Public Notice shall be placed on the website of the NBPDCCL.</li> </ul>
