Eligibility Criteria.

- 1. The work involves SITC of 10KWp Rooftop solar power plant.
- Specialized firms who fulfill the following eligibility criteria requirements. Joint ventures are not acceptable.
 - a) Should have satisfactorily completed the works as mentioned below during the last Seven years ending previous day of last date of submission of bids in Central Government, State Government Organization Autonomous body of Central Government & State Government.

- b) Information and instructions for bidders posted on website shall form part of bid document.
- c) The intending bidder must read the terms and conditions of CPWD-6 carefully. He should submit his bid only if he considers himself eligible and he is in possession of all the documents required.
- d) The bid document consisting of specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/cpwd or www.tenderwizard.com/cpwd www.tenderwizard.com/cpwd</a

- e) Those bidders not registered on the website mentioned above, are required to get registered before hand. If needed they can be imparted training on online tendering process as per details available on the website.
- f) The intending bidder must have valid Class-III digital signature to submit the bid.
- g) On opening date, the bidder can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- h) Bidder can upload documents in the form of JPG format and PDF format.
- i) Bidder must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
- j) The PQ bid shall be opened first on due date and time as mentioned above. The time and date of opening of technical cum price bid of intending bidders qualifying the PQ criteria shall be communicated to them at a later date.
- k) If it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
- I) The bidder can deposit original EMD either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission. The bidder shall obtain the receipt of EMD from the concerned Executive Engineer (including NIT issuing Executive Engineer) in the prescribed format uploaded by NIT issuing Executive Engineer. The bid documents as uploaded can be viewed and downloaded free of cost by anyone including intending bidder. But the bid can only be submitted after uploading the mandatory scanned documents such as Demand draft/ Pay order or Banker's cheque/ Bank guarantee of any schedule Bank towards EMD in favour of respective Executive Engineer, copy of receipt of original EMD and other documents specified in the press notice.
- m) But the bid can only be submitted after uploading of EMD declaration within the period of bid submission and uploading the mandatory scanned documents such as Demand Draft or Pay order of Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of Executive Engineer as mentioned in NIT, receipt for deposition of original EMD to division office of any Executive Engineer (including NIT issuing EE), CPWD, and other documents as specified.

A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lakhs, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of Scheduled Bank having validity for 6 months or more from the last date of receipt of bids which is to scanned and uploaded by the intending bidders.

- i) Copy of Certificate of work experience and other documents as specified in the press notice shall be scanned and uploaded to the e-tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in press notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.
- ii) Online bid documents submitted by intending bidders shall be opened only of those bidders, whose EMD declaration and other documents scanned and uploaded are found in order.
- n) The Bid submitted shall become invalid if:
 - i) The bidder is found ineligible.
 - ii) The bidder does not upload EMD declaration.
 - iii) The bidder does not upload all the documents (including GST registration) as stipulated in the bid document including the copy of receipt for deposition of original EMD instrument.
 - iv) Certificate of Registration for GST and acknowledgement of upto date filed return as per NIT stipulation.
 - v) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest tenderer in the office of tender opening authority.
 - vi) If a bidder quotes nil rates against each item in item rate tender or does not quote any percentage above/ below on the total amount of the tender or any section/ sub head in percentage rate bid, the bid shall be treated as invalid and will not be considered as lowest bidder.

- o) The Eligibility criteria documents shall be opened first on due date and time. The time and date of opening of technical cum financial bid of the bidders qualifying the eligibility criteria shall be communicated to them at the later stage.
- p) The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified bidders to any number deemed suitable, if too many bids are received satisfying the laid down criterion.
- q) It is mandatory to upload scanned copies of all documents including GST registration if these documents are not uploaded, then bid will become invalid and summarily be rejected.
- r) The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
- s) After submission of the bid the agency can re-submit revised bid any number of times but before last time and date of submission of bid as notified.

List of Documents to be scanned and uploaded within the period of bid submission:

- i) Self attested copies of completion certificates(s) issued by the officer of the client department, not below the rank of Executive Engineer or equivalent. The completion certificate must clearly indicate:-
 - (a) Name of Work.
 - (b) Stipulated date of start and actual date of completion.
 - (c) Value and nature of work.
 - (d) That the work has been completed satisfactorily.
 - (e) Full address of the client, officer issuing certificate and location where work is executed.
- ii) Proforma for EMD declaration (Form B).
- iii) Valid Electrical License (Tenders of only those contractors will be opened who have uploaded valid Electrical license from competent authority in the name of contractor (Refer Correction Slip vide No. DG/SE/CM/ENLIST.RULES/Misc./02 dated 14.07.15).
- iv) Certificate of Registration for GST and acknowledgement of up to date filled return (GSTR-3B).

If the bidder has not obtained GST registration in the State in which the work is to be taken up or as required GST authorities then in such case the bidder shall scan and upload following undertaking alongwith other bid documents.

"If work is awarded to me, I/we shall obtain GST registration certificate of the state in which work is to be taken up within one month from the date of receipt of award letter or before release of any payment by CPWD, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by CPWD or GST department in this regards."
