Mode of Payment towards Cost of the Tender Document, EMD & Tender processing Fee: to be paid online through e- payment mode via NEFT/RTGS /net banking (Axis bank) with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challan and upload the scanned copy of NEFT/RTGS/ net banking (Axis bank) challan along with the bid
- e. The applicant should scan a declaration giving the names of the works in hand in the above mentioned category on stamp paper of Rupees 100/-




## **INSTRUCTION TO CONTRACTORS**

1. The intending bidder must read the terms and conditions carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://eprocure.goa.gov.in>
4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
5. The intending bidder must have/ obtain a valid Class-III digital signature to submit the bid.
6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
7. Bidder must ensure the amount put to tender of each work.
8. Estimated cost put to tender is including GST/CGST.
