Name of work:- Supply, Installation & Commissioning of 25KW On-Grid Roof Top Solar Power System.

The applications shall include all taxes, transportation charges, installation charges etc. The Panchayat reserves the right to accept or reject any or all the applications without assigning any reasons thereof. The suppliers/dealers whose bid if accepted by the Panchayat must be in a position to supply the same within 15 days from the receipt of the order.

The online application should accompany the following documents (scan and upload on the e- tender website):

b. Attested copy of PAN Card

c. Attested copy of GST registration Certificate.

Mode of Payment towards Cost of the Tender Document, EMD & Tender processing Fee: to be paid online through e-payment mode via NEFT/RTGS/net banking (Axis bank) with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challan and upload the scanned copy of NEFT/RTGS/net banking (Axis bank) challan along with the bid.

INSTRUCTION TO CONTRACTORS

- 1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required as per tender document.
- 2. Information and Instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from web site https://eprocure.goa.gov.in
- 4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- 5. The intending bidder must have/ obtain a valid Class-III digital signature to submit the bid.
- 6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 7. Bidder must quote for unit item inclusive of all taxes and the duties as applicable at the time of submission of bid.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason there of is reserved.
