The estimated basic cost of the work is Rs.40.67Lakhs /- excluding GST. Total cost of estimate is Rs.47.97/- inclusive of GST @ 18%. ## 1. Minimum Qualifying Criteria:-

The Firm/Company, as the case may be (hereinafter referred to as "The Tenderer"), shall have following Minimum Eligible Qualification:

The tenderer must fulfill the following qualifying requirements to consider him technically qualified and eligible for opening its Price-Bid and for award of Work.

- a. The average annual financial turnover of the tenderer during the last three years ending 31st March 2020 shall be at least Rs.12.20 /- Lakhs In support of this, the Tenderer should submit copies of audited P&L A/c statements and Balance sheets for last 03 Financial Years, (2017-18, 2018-19, 2019-20) duly certified by the Chartered Accountant (C.A.) clearly indicating registration number. Also submit CA certificate for last three financial years. (2017-18, 2018-19, 2019-20).
- b. The tenderer should have successfully completed similar work/s i.e. "Supply, installation & commissioning of Roof Top solar system minimum **400 kWp** (& /or) AMC/CMC of roof Top solar system minimum up to 400 kwp" during the last 07 (seven) years ending on the last day of month previous to the one in which tenders are invited, shall be any of the following:
  - i. Three completed works each costing not less than the amount equal to Rs.16.26/- Lakhs OR
    - Two completed works each costing not less than the amount equal to Rs.20.33/-Lakhs OR
    - iii. One completed work costing not less than the amount equal to Rs.32.53 / Lakhs -.
- **c.** The tenderer shall have the experience of Annual Maintence of solar system during last last 05 years. Tender shall submit one work order for Annual Maintence contract work.
- **d.** Tenderer shall own the PV Tool (for module testing, module string testing, IV Curve tracing, Module IR Testing. Necessary proof shall be submitted.
- e. The tenderer shall have office set up in Mumbai/Navi Mumbai. Tenderer has to submit Maharashtra shop establishment certificate or any kind of certificate from which it can be proved the tenderer is located in Mumbai/Navi Mumbai. The Tenderer should submit documentary evidence in this regard.

f. The tenderer must have PAN and registered with GST Authority. The tenderer shall submit copy of PAN and valid GST Registration Certificates issued by the appropriate Government Authority or Department

The tenderer shall submit the documentary evidence to prove that they have executed the above works successfully & satisfactorily. In support of this, the tenderer shall submit the copy/copies of order/s in full along with relevant annexures/documents forming the part of the order or orders. In addition to this, the tenderer shall also enclose the copy/copies of the satisfactory performance/completion certificates to demonstrate completion of the corresponding order or orders under consideration. In case the work order is executed for Private firm, copy of TDS document shall be submitted along with work order and completion certificate.

Tenderer shall note that SCANNED COPY OF ORIGINAL documents related to MQC shall be uploaded without fail. Tender will be scrutinized on the basis of submitted documents only
