

NOTICE INVITING BID (2ND CALL)

1. CIDCO of Maharashtra Limited through the process of E-tendering invites “ON LINE” Item Rate bids in two bid system (Part I: Technical Bid & Part II: Commercial Bid) from experienced and eligible prospective bidders fulfilling the mandatory eligibility criteria and scoring minimum qualifying marks of 75 in the Technical Bid Evaluation, comprising of total 100 marks and who have completed work of similar nature work as mentioned below:

2. Conditions of Eligibility of Applicants
- 2.1 Applicants must read carefully the minimum conditions of eligibility (“**Conditions of Eligibility**”) provided herein. Proposals of only those Applicants who satisfy the Conditions of Eligibility will be considered for evaluation of the Proposals.
- 2.2 To be eligible for evaluation of its Proposal, the Applicant shall fulfil the following:
- (A) **Technical Capacity:** The Applicant shall have, over the past Five (05) years preceding the PDD undertaken a minimum of Eligible Assignments as detailed in Section 3.
- (B) **Financial Capacity:** The Applicant shall have received an average annual turnover of at least INR 100 Crore (Indian Rupees Fifty Crore) during the last 5 (Five) financial years preceding the Proposal Due Date.
3. Eligible Assignments
- For the purposes of determining Conditions of Eligibility and for evaluating the Proposals under this RFP, the following construction projects covered under the advisory/ consultancy assignments; shall be deemed as eligible assignments (“**Eligible Assignments**”):
- The Consultant should have experience of completion of Detailed Project Reports of Solar Power Generation in urban area in the last 5 years for-
- i) ONE project of minimum 80 MW
OR
- ii) TWO projects of minimum 50 MW
OR
- iii) THREE projects of minimum 40 MW
- The Consultant must submit certificates issued by the competent authority/ Final Client/ Concessionaire as evidence of the professional services provided.

Notes:

- a) The information regarding Financial Criteria and Average Annual Turn Over Certified by Chartered Account will be only considered.
- b) If bids are called between 1st April & 30th September of the year then latest audited financial year shall be a year before previous year for financial criteria. (for e.g. if bids are called between 1st April 21 & 30th Sept. 21, then latest audited financial year shall be a year before previous year for financial criteria i.e. 2019-20)

4. GENERAL NOTES:

- 1) The online submission will be considered responsive only if it is accompanied by
 - i) Goods & Service Tax (GST) Registration Certificate / GST No.
 - ii) Income Tax Permanent Account No, (PAN).
 - iii) List of total staff mentioning their details such as their qualification, experience & other details etc.
 - iv) CV's of Key Personnel & Sub-Professionals with their attested educational certificates.
 - v) Undertaking for Deployment of Sub-Professionals.
 - vi) List of equipment (software and hardware),
 - vii) List of similar works & it's magnitude executed in last Five years along with work completion certificates.

If prospective bidder fails to upload scan copies of above document, then his bid will be considered as non-responsive and disqualified from taking other part in the bid process. The applicant should also produce original documents for verification if called for. Failure to attach requisite documents with application, or to produce original documents, will render applicant not eligible for qualification of bid without any intimation.

- 2) In case of damaged documents / non openable documents / relevant balance documents of already uploaded documents not found after opening of technical bids then the hard copies of that documents shall be accepted subjected to such documents shall be in possession by the bidder before the later date specified in the e-handover of the prepared documents.
- 3) CIDCO reserves right to reject any or all Bids without assigning any reason and the same shall be at the entire discretion of CIDCO. CIDCO's decision in this respect shall be final and binding.
- 4) Conditional Bids shall be summarily rejected.
- 5) Bidder will not be eligible to participate for bidding, if
 - i) the bidder is deemed by law unable to pay his debts as they fall due, or enters into voluntary or involuntary bankruptcy, liquidation or dissolution (other than a voluntary liquidation for the purpose of amalgamation or reconstruction), or becomes insolvent, or makes an arrangements with, or assignment in favour of, his creditors, or agree to carry out the bidding under a committee of inspection of his creditors, or if a receiver, administrator, trustee or liquidator is appointed over any substantial part of his assets, or if, under any law or regulation relating to reorganization, arrangement or readjustments of debts, proceedings are commenced against the bidder or resolutions passed in connection with dissolution or liquidation or if any steps are taken to enforce any security or interest over a substantial part of the assets of the bidder, or if any act is done or event occurs with respect to the bidder, or if any act is done or event occurs with respect to the bidder or his assets which, under any applicable law

has a substantially similar effect to any of the foregoing acts or events, then the bidder is not eligible to participate in bidding process.

- ii) blacklisted/debarred/convicted / defaulters within last three years in any other Govt., Semi Govt. organizations and CIDCO awarded contract are not eligible to participate the bidding process.

Intending bidders should furnish the Affidavit duly notarized on stamp paper of Rs.500/- in line with content of Sr. No. above of NIB.

- 6) The offer shall remain valid for a period of one hundred twenty (120) days from the later date specified in the e-handover of the prepared document.
