- 1. The applicant in the same name and style as prime contractor should have successful completed at least one contract of similar type of Civil Engineering work to a value of 40% of estimated cost in a single tender completed within last 5 years, from the Govt. / Semi Govt. Organisations.
- 2. The contractor should have sufficient technical manpower, tools and plants to complete the work.
- 3. GST IT (PAN Certificate, and IT Return submitted for the last financial year); GST registration certificate with up to date return; and P.T. clearance certificate up to date.

- 4. All duties, taxes, royalties, cess [including 1% cess under W.B. Building and other Construction Workers(Regulation of Employments & Condition of Service) Act,1996], toll taxes and other levies payable by the contractor under the contract to the State / Central Government for any other cause, shall be included in the rates, prices and total bid price submitted by the bidder. 1% cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare cess Act, 1996 will be deducted from running bills.

- 1. The intending bidders are requested to read these instructions carefully and inspect the site before quoting the rates.
- 2. The tender will be Two Folder System. One folder will be for "**Technical bid**" containing mainly pre- qualification as specified (3) bellow. Other folder will be for "**Financial bid**" containing offer as specified (4) bellow.
- 3. The folder marked "**Technical bid**" will contain the following documents:-
- a) For biding documents downloaded from website, the Bank Challan for the cost of biding documents entered in the **Technical Bid**, marked 'cost of bidding documents downloaded from the website.

- 4. The folder marked **'Financial Bid"** will contain the following documents. a)The BOQ containing Bid, offer on the basis of percentage (less / at par). b) Bill of Quantity (Tender Schedule).
- 5. The applicant in the same name and styles prime contractor should have successfully completed at least one contract of **any type** of Civil Engineering work except earth work to a value of 40% of estimated cost in a single tender completed within last 5 years, from the Govt. / Semi Govt. Organisations.

- 6. The bidder should submit the original documents for verification at the time of bid opening
- 7. Successful tenderers will have to execute an agreement with the Pradhan, Betkundu Gram Panchayat, on a non judicial stamp paper valued Rs. 10/- (Rupees ten) only within the date specified in the letter information.
- 8. Tenderers must submit requisite credential certificates from **Appropriate Authority.**
- 9. Contractors shall have to comply with the provision of (a) The contract labour (Regulation application) Act, 1970 (b) Apprentice Act, 1961 or (c) Minimum wages Act, 1948 and the modification thereof by other laws relating to the rates and rules made and issued hereunder from time to time.
- 10. Intending tenderers will have to produce valid certificates of up to date clearance of Trade License, Income Tax / GST documents.
- 11. Cost of bidding documents should be deposited in form of Demand Draft (D.D.)/ Bankers Cheque (B.C.) in favour of the Ptadhan, Betkundu Gram Panchayat & deposited money will be released to the unsuccessful tenderers after issuance of the work order.
- 12. The Earnest Money should be deposited in form of D.C.R./ term deposit in favour of the Pradhan, Betkundu Gram Panchayat & deposited money will be released to the unsuccessful tenderers after issuance of the work order.
- 13. Cement, Steel & Bitumen materials should be ISI approved brand as directed by E.I.C. The all above materials are to be arranged by the **Agency** himself for bonafide use of the work.
- 14. Authority reserves the right to accept or reject any or all tender without assigning any reason or whatsoever and is not bound to accept the lowest tender.
- 15. Work must be completed within the specified time
- 16. The Tenderer whose tender has been accepted and executed the agreement the earnest money deposited by him will automatically be converted into security deposit. An amount of 8% of the value of work executed will be deducted from the each progressive bill. This amount along with 2% Earnest money deposited earlier will be constituted the Security Deposit. Such security deposit willbe refunded after completion of defect liability period i.e.**one year for repairing work and 3 years for new Construction** after satisfactory completion of the work. In case of failure to complete work within the stipulated time the security deposit will be **forfeited** without assigning any reason thereof.
- 17. If the lowest tenderer fails to executive the agreement within the date mentioned in the letter of
- information, his name should be brought into book for taking disciplinary action and his earnest money will stand forfeited.
- 18. In the event of the tender being submitted by a firm, it must be signed separately by each member thereof and in the event of the absence of any partner, it must be signed on his belief by a person holding a power of attorney authorizing him to do so.
- 19. This Notice Inviting Tender will be the part of agreement.
- 20. Proportionate quantity of work is to be done in proportionate time throughout the stipulated time for completion.
- 21. Payment of work will be made as per fund available for Govt., for which no extra claim shall be entertained.
- 22. All duties, taxes, royalties, cess, [including 1% cess under W.B. Building and other Construction Works (Regulation of Employments & Condition of ServiceWelfare Cess Act, 1996)], toll, taxes and other levies payable by the Contractor under the contract to the State/Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% cess under Building and other Construction Works (Regulation of Employments & Condition of Service)** Welfare Cess Act, 1996 will be deducted from the bills.
- 23. All tenderer, who has submitted tender, are requested to attend at the time of opening tender.

- 24. No Sub-Contracting is lowed.
- 25. Rate offered by agency beyond 15% less may be treated as Unbalanced Bid. In such case of unbalanced bid, the bidder may be asked to deposit additional 2% of tendered amount in deposited in from D.C.R. / Term deposit in favour of the Pradhan, Betkundu Gram Panchayat and which will be released after successful completion of the work.
- 26. The bidder shall be responsible for the insurance done against work after getting the work order from the General Insurance Company, / Oriental Insurance Company, Govt. Of India, Purba Medinipur, Tamluk.
- 27. No claim for escalation of rates will be entertained during the currency of the tender for idle labour or increase in the cost of labour or materials.
- 28. Programme of works acceptable to the department should be submitted before physical commencement of work and every effort should be made to adhere strictly to this approved work programme.
- 29.Issuance of work order as well as payment will depend on site clearance, availability of materials

and availability of fund in appropriate head and on claim whatsoever will be entertained for delay issuance of work order as well as payment. Works should be completed within stipulated period. If any, intending tenderers may outsider these criteria while quoting their rates.

30. There will be no scope of Arbitration.
