- 6. Each Bidder should have in any one year a minimum financial turnover during the last 5 years (in all cases of civil engineering construction works only) volume of construction work of at least the amount equal to the 30% of the estimated cost of work. The turnover will be indexed at the rate of **8 percent simple interest for a year**. (The respective payment certificates are to be attached).
- 7. Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity **for construction work** is equal to or more than the total bid value. The available bid capacity will be calculated as under.
 - a. Assessed Available Bid capacity = (A*N*M-B)

Where

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer in charge, not below the rank of an Executive

- 17. The Tenderer whose tender has been accepted and executed the agreement the earnest money deposited by him will automatically be converted into security deposit.
