2	Electronic tender forms shall be opened in the office of the Municipal Council Samana, in the presence of Contractors or their authorized representatives (if they wish) on the date and time prescribed in the tender notice.	
3	If any date of tender happens to be a holiday, the tenders shall be received and opened on the next working day.

5	Bidders/Contractors/tenderers can access tender documents on the website <a href="www.eproc.punjab.gov.in">www.eproc.punjab.gov.in</a> , fill them and submit the completed tender document into Electronic Tender on the website itself.
