Cost of Tender Papers and Earnest money should be deposited by the Bidder electronically. Online through his net banking enable bank account maintain at any bank or offline through any bank by generating NEFT/RTGS challan form the e-tender portal (www.bbtenders.gov.in) using bidder Digital Signature Certificate.

The pre-qualification documents alone will be opened on 25/01/2022 at 10.00 hours. By the Prodhan, BAHADURPUR Gram Panchayat in presence of bidders present.

The date for opening of financial bid documents of the technically qualified bidders on 27/01/2022 and the other bid documents will be unopened. No individual intimation will be given. Date for opening of financial bid documents and name of the technically qualified bidders will be displayed in the office notice board.

The Prodhan, BAHADURPUR Gram Panchayat reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

- The credential should be submitted/uploaded at least 50% Up to 5.00 Lakh, 40% for 5.00 Lakh to 10.00 Lakh, 30% Above 10.00 Lakh of the amount put to Tender supported by final payment Certificate and Completion Certificate along with work order within the last 3 years in the Same type of work & completed the work successfully.
- A printed letter Head Pad of the concerned agency must submit with the tender.
- The Credential should be in the name & style of the intending bidder only, and not in the name and / or style of any of the Partner(s). Please note that, Final Payment Certificate or Completion Certificate along with Work Order, Schedule and Bank statement of the uploaded (1 Set) credential will only be entertained as CREDENTIAL.
- Income Tax return should be submitted/uploaded for the last 3(three) financial years with Audit Report.

Please note that, **Final Payment Certificate or Completion Certificate along with Work Order, Schedule and Bank statement of the uploaded (1 Set) credential will only be entertained as CREDENTIAL.**

4. Income Tax return should be submitted/uploaded for the last 3(three) financial years with Audit Report.
5. Valid Trade license, Up to date Professional Tax receipt Chalan for the year **2020-21**, G.S.T Registration/Acknowledgements with last update & Pan Card should be submitted/uploaded.
6. **A prospective bidder shall be allowed to participate for 3 (three) works for single NIT.** In the work either in the capacity of individual or as a partner of a firm, if found to have applied severally in a single NIT, all his applications will be rejected for that NIT.
7. The partnership firm shall upload the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
8. Intending Labour Co-Operative Societies & Unemployed Engineers' Co-Operative Societies should enclose the documents in proof of their Registration & Validity to participate in this Tender during the period of deposition of the Tender and the current audit report. In case of Registered Labour Co-operative & unemployed Engineers' co-operative shall have to participate in the tender, no special Preferences in respect of earnest money, security deposited.
9. Receipt copy of deposit (Cost of Tender Paper & earnest money by bidders own A/C no. only) Challan should be submitted/uploaded with the tender documents/Bids. **Without Earnest Money tender will be liable to cancel.**
10. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
11. All the documents in proof of their eligibility IN ORIGINAL SCAN COPY need to be uploaded & produced as and when asked and required.
12. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned, the disputed amount, and the matter.
13. To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience. Sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
14. The scope of Sub-Contracting is not allowed strictly by anyway.
15. If there are any complain against any participant contractors regarding credential/tender document, they may inform to this office in written before opening of Financial Tender bid otherwise the complain may not be entertained. Beside this any false complain will be treated as punishable offence and hence as a punishment they will not be allowed to participate next three consequent tenders.
16. **Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:**
 - 1) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).
 - 2) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
 - 3) Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.
17. Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda.
18. Affidavit attested by Notary Public should be submitted/uploaded with the tender documents.
19. Time is essence in these works. So no extension of time shall be entertained in any way.
20. After submission of tender bid, it cannot be withdrawn. If any contractor is unwilling (reason whatever may be) to do the work after issuing work order, it will be treated by the undersigned that the contractor participated for hampering the tender process and for this reason his Page 4 of 4 earnest money will be forfeited and his application for participation in tender process will be rejected by the undersigned for the next three consecutive tender from this office.
21. Affidavit attested by Notary Public should be submitted/uploaded with the tender documents. [Format enclosed with SBD].
22. The contractor will have to clear the site after completion of work as per direction.
23. If any successful tenderer does not receive work-order within 7 (Seven) days without any cause or does not satisfy the authority for such delay, the authority has the right to take penal action against him & his work-order will be cancelled and his earnest money will be forfeited.
24. As per order No-1386(5)/P&RD Dated-17/10/2019 if quoted rate less than 15% then 5% extra earnest money. If quote rate less than 20% and above then 10% extra earnest money should be submitted before work order upon the Tender Amount.
25. After completion the work bidder must be submitted concrete cube test report in the office.
26. All other Govt. rules must be applicable as per standard Bidding document which is kept in the office of undersigned.

Amount of earnest money is 2% of the estimated cost of construction for each work. All duties, taxes, royalties, Cess, [including 1% under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.

The intending bidders are requested to inspect the work site of the proposed work before quoting their rates. No plea/complain about the site approach road, natural or political disturbance etc. may not be entertained in any way.
