F.3(620)/Tariff-Engg./DERC/2020-21/6846- The Delhi Electricity Regulatory Commission, in exercise of the power conferred under Guideline 17 of *Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) Guidelines, 2019* and all other powers enabling it in this behalf and after previous publication, hereby amend the following Guideline in Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) Guidelines, 2019 (hereinafter referred to as “the Principal Guidelines”):

**1.0 Short Title and Commencement:**

- (1) These Guidelines may be called the Delhi Electricity Regulatory Commission (Group Net Metering and Virtual Net Metering for Renewable Energy) (Fourth Amendment) Guidelines, 2022.
- (2) These Guidelines shall come into effect from the date of uploading on DERC website.

**2.0 Amendment of Guideline 13 of Principal Guidelines:**

In Guideline 13 (Applicability of Other Charges), the following shall be substituted as:-

**“13. Applicability of other charges**

*The Renewable Energy System commissioned under DERC (Net Metering for Renewable Energy) Regulations, 2014, shall be exempted during its useful life from payment of Wheeling Charge, Banking Charge, Cross Subsidy Surcharge and any other charge(s), as decided by the Commission by an order.*

*Provided that exemption of applicability of such charges shall be valid till commissioning of Renewable Energy System by 31<sup>st</sup> March 2024 or till additional capacity reaches upto 75 MW, 50 MW, 30 MW and 10 MW for BRPL, TPDDL, BYPL and NDMC respectively for projects under Virtual Net Metering and Group Net Metering in each Distribution Licensee, whichever is earlier.”*

**Instead of**

**“13. Applicability of other charges**

*The Renewable Energy System commissioned till 31<sup>st</sup> march 2022 under DERC (Net Metering for Renewable Energy) Regulations, 2014, shall be exempted during its useful life from payment of wheeling charge, banking charge, cross subsidy charge and any other charge(s), as decided by the Commission by an order.”*
