1. Introduction

1.1 Invitation

Under the provisions of the Energy Conservation Act, 2001, Madhya Pradesh Urja Vikas Nigam has been established as State Designated Agency (SDA),

The mission of the State Designated Agency is to assist in developing policies and strategies with a thrust on self-regulation and market principles, within the overall framework of the Energy Conservation Act, 2001 with the primary objective of reducing energy intensity of the Indian economy. This will be achieved with active participation of all stakeholders, resulting in accelerated and sustained adoption of energy efficiency in all sectors.

This RFP Document is for **Empanelment of consultants** to work as ESCO agency and/or for the work of Energy auditing and study for energy management programme in the state of Madhya Pradesh. The main objective is to provide consultancy support in carrying out the Energy Conservation Activities in the state of Madhya Pradesh. The activities may include Energy auditing, industry interaction, awareness campaign, implementing EC projects etc.

1.2 Background

With growth in economy, demand for energy has grown substantially and high level of energy intensity in some of major sectors is a matter of concern. In all sectors of the economy, improving energy efficiency rather than increasing energy supply is generally considered more economical and environmentally efficient strategy. The emphasis of future is to look for technologies which promote energy efficiency, demand side management and conservation of energy. Energy efficiency assumes significance for the nation in current scenario of heavy dependency on fossil fuels and concerns over climate change. It is a winwin situation for all– for consumers, increased energy efficiency means availability of more resources for better utilization elsewhere; for nations, energy efficiency offers a number of benefits including improved use of natural resources, reduced energy imports, improved balance of trade, conservation of foreign exchange (Forex), reduced capital requirement for new energy production facilities and reduced environmental pollution from energy use and production.

Recognizing the fact that efficient use of energy and its conservation is one of the least-cost option to meet increasing energy demand, Government of MP has designated MPUVNL as State designated agency in 2004 and setup Energy Management Cell (presently under Department of New and Renewable Energy,

GoMP) to give impetus on promotion and popularization of energy efficient technologies.

MPUVNL keeps endeavouring to focus on efficient, affordable and transformative technologies and necessary shift in policy framework to drive necessary correction in accumulated sustainability deficit for a cleaner future. 2.4 General terms and conditions

Subject to amendment Following shall be followed:

- a. Full bid/ proposals shall be submitted to MPUVNL through Online & offline (in hard copies) at given address.
- b. Interested bidders are required to pay **Rs.2000/-** as bid/ proposal processing fees (Non-refundable).
- c. All proposal documents shall be either in Hindi or English languages. Any support document in other language or script shall be accompanied by Hindi or English translation of the same.
- d. Each format/ document has to be duly signed and stamped by authorized signatory of the bidder/ lead member.
- e. Bidder shall furnish all necessary documentary evidence (Duly self attested or signed by authorized signatory) in support of meeting eligibility criteria as indicated in this RFP to the satisfaction of MPUVNL.
- f. RFP shall remain valid for 90 days from date of submission
- g. Bidder shall designate one person to represent it in its dealings with MPUVNL. The person should be authorized to perform all tasks including

but not limited to providing information, responding to enquires, signing of RFP etc.

- h. Bidder may seek clarifications to RFP in writing, through e-mail to reach MPUVNL on or before date and time mentioned in RFP. However, MPUVNL is not under any obligation to entertain/ respond to suggestions made or to incorporate modifications sought for.

2.6 Procedure for Submission of RFP

- a. The consultant has to submit bid online as well as through offline mode.
- b. The consultant should submit one hard copy of the proposal in sealed cover. The copy of proposal should be a complete document and should be bound as a volume separately.
- c. The document should be page numbered and appropriately flagged and should contain the list of contents with page numbers. The deficiency in documentation may result in the rejection of the Bid/offer.
- d. The sealed cover should be super scribed with the wordings "EMPANELMENT AS CONSULTANT FOR ENERGY AUDIT WORK & ESCOs.

2.7 Online submission of proposal

- a. Consultants are advised to note that No financial proposal/ bid are required under this RFP. Only technical proposal/ RFP is to be submitted online/ offline along with all necessary and supporting documents. MP Tenders Portal shall have necessary customization for the same.
- b. For participation in e-tendering module, it is mandatory for interested Consultants to enroll on the e-Procurement module of the MP Tenders Portal (URL: https://mptenders.gov.in/) by clicking on the link "Online bidder Enrolment" on the MP Tenders Portal. Cost of Enrolment and renewal is dependent on the Government Order (GO) prevailing at the time.
- c. As part of the enrolment process, Consultant will be required to choose a unique username and assign a password for their accounts.
- d. Consultants are advised to register their valid e-mail address and mobile numbers as a part of the registration process. These would be used for any communication from the MP Tenders Portal.
- e. Upon enrolment, Consultants will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- f. Only one valid DSC should be registered by a Consultant. Please note that Consultants are responsible to ensure that they do not lend their DSC's to others which may lead to misuse or even disqualification.
- g. Consultant then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

3. Evaluation of RFP

3.1 **Preliminary Scrutiny**

Preliminary scrutiny of the proposal will be made to determine whether they are complete, whether required process fee has been furnished, whether the documents have been properly signed, and whether the bids are generally in order. Proposals not conforming to such preliminary requirements will be prima facie rejected. Decision of MPUVNL will be final and binding in this regard.

3.2 Evaluations of Proposals

The proposals would be evaluated on the basis of the pre-qualification criteria and Consultant's prior experience in the areas mentioned above. However, MPUVN LTD in its sole/absolute discretion can apply whatever criteria deemed appropriate in determining the responsiveness of the RFP submitted by the respondents.

MPUVNL may seek necessary information or document or clarification from Consultants as relevant for evaluation and prudent assessment of concerned proposal.

4. Authorized Signatory (Consultant)

The "Consultant" as used in the RFP shall mean the one who has signed the RFP document forms. The Consultant should be the duly Authorized Representative of the firm/establishment, for which a certificate of authority will be submitted. All certificates and documents (including any clarifications sought and any subsequent correspondences) received hereby, shall, as far as possible, be furnished and signed by the Authorized Representative. The power or authorization, or any other document consisting of adequate proof of the ability of the signatory to bind the Consultant shall be annexed to the bid/offer.

5. Amendment of RFP

At any time prior to the last date for receipt of bids, MPUVN Ltd., may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Consultant, modify the RFP Document by an amendment.
