TERMS & CONDITIONS

- Inspection vehicle is to be provided in good running condition.
- 2 The contract shall be for 02 months, however contract can be terminated any time without any reason.
- 3 The Driver shall be of good behaviour, well experienced and having valid driving licence with impeccable integrity.
- 4 Nothing extra shall be paid on account of driver's salary, cost of oil, repairs and maintenance of the vehicle and cost of insurance etc.
- 5 The spare stepney and maintenance tools shall always be available in the vehicle. No T&P shall be issued to Contractor for this work.
- 6 Km. Reading shall be counted in the morning when Vehicle i/e Driver reports for duty to Officer in charge and closed for the day when the Officer in charge left the vehicle. Starting Point of duty shall be counted at the O/O EE (E), GED, CPWD Gorakhpur.
- 7 Driver Shall be fully Conversant with U.P. Traffic rules and road sign.
- 8 The department shall not be responsible if any accident or repair of the vehicle be happen and as such all expenditure shall be beared by the contractor.
- Any damage/mishappening/legal proceedings compensation occurred during the execution of the contract shall be beared by the contractor and department shall not be responsible for any such incident. Make and Model of Vehicle (Mahindra, Hyndai, Maruti Suzuki, Honda, Tata). Another Models/Makes of Vehicle is not Acceptable.
- 10 The owner of the vehicle will be responsible for any loss of life or property by the use of vehicle.
- 11 The vehicle will be kept in the office premises of the officer-in-charge.
- 12 If the owner/contractor fails to provide the vehicle on any working day/on demand/failure on the tour, recovery @ Rs. 3000/- per day will be made.
