The Scope of work is indicative in nature but not limited to the following and bidder must include their areas that shall be required for successfully delivering the scope:

1. Submission of Technical Feasibility Report and Detailed Project Report

1.1 Technical Feasibility Report:

- a) The Consultant shall conduct water quality checks (pH level, Conductivity, Resistivity etc.)
- b) The Consultant shall check the Power Interconnection facilities and existing infrastructure and suggest for modification required (if any) for FSPV plant grid connection.
- c) The Consultant shall assess the suitability of the site for installing a Floating Solar PV system, including a review of the local climatic conditions.

1.2 Detailed Project Report:

- a) The Consultant shall carry out the detailed site survey including bathymetric study, water body characteristics, geo-technical investigation (on shore/off shore) etc. and shall apprise RECPDCL regarding information such as water properties (such as TDS content etc), depth of reservoir (Full Reservoir Level (FRL), Minimum Drawdown level (MDDL), Dead Storage level etc., variation in the depth of water reservoir, water flow rate/current, climatic conditions, requirement of statutory approvals etc., as a part of DPR.
- b) DPR to be prepared by the consultant shall include energy yield calculation and calculate Performance Ratio and P50, P90 and P99 production forecasts, cost estimate, Soil test report.
- c) DPR will consist detailed Bill of Material's, Single line diagrams, Power Evacuation Arrangements, safety aspects of the projects, different options for operation and maintenance.
- d) Draft DPR is to be discussed with RECPDCL time to time and the changes as suggested are to be incorporated.

2. Preparation of RfP documents and Bid evaluation:

- a) The Consultant shall prepare the RfP for engaging of EPC Contractor including project related details like feasible capacity, scope of work, qualification requirements, payment terms, technical specifications to ensure maximum life of the project, Operation & Maintenance Contract. The consultant shall prepare the all-necessary drawings and design required for tendering purpose.
- b) The Consultant shall evaluate the technical and financial bids submitted by EPC Contractor as per EPC tender.

3. Activity during Construction Phase:

- a) The Consultant shall review all the Drawings/Design submitted by EPC Contractor in line with technical specifications specified in EPC Contract to ensure appropriate compliance in terms of performance and safety.
- b) The consultant shall provide technical support during construction phase including submission of weekly progress report. Such support may be provided from consultant own office through VC/ e-mail etc. Consultant shall be engaged in day-to-day activities and provide timely clarifications as and when required till successful commissioning of project.
- c) In case of project requirement technical consultant shall visit the site during construction phase as and when required by RECPDCL. Total 10 such visits shall be the part of this contract and price for the same to be factored in total quoted price. However, visits beyond 10 No's shall be paid extra @ Rs. 20,000 per visit (these charges will be inclusive of all expenses towards travel and lodging). Such visit should be performed by the key professional consultant whose CV is to be submitted along with technical bid.
- d) Performance Ratio (PR) Test: The Consultant shall perform PR test post commissioning of the project.
- e) Quality Check Report: The Consultant shall submit quality check report for rectification by the EPC Contractor and shall check the as built drawings / documents submitted by the EPC Contractor post commissioning of project.

BID EVALUATION METHODOLOGY

1. OPENING OF BIDS:

Opening of Bids will be through online only.

- a) Bids duly submitted, will be opened on the date and time indicated in this document in the presence of bidders or their authorized representatives who desire to present.
- b) If due date of receipt / opening of bids happens to be a closed holiday, the bids would be received and opened on the next working day.
- c) REC PDCL reserves the right to postpone and/or extend the date of receipt/opening of Bids or to withdraw the Tender notice, without assigning any reason thereof. In any such cases, the bidders shall not be entitled to any form of compensation from the Company.

2. Techno-Commercial Evaluation of Bidders:

- a) All the received bids will be subjected to Techno-commercial evaluation as per Qualification Criteria defined. Only Qualified bids will be considered for further evaluation. On completion of Techno-commercial bid evaluation, if it is found that only one bidder is eligible for that particular Project, opening of the financial bid of the bidder will be at the discretion of RECPDCL. Thereafter, RECPDCL will take appropriate action as deemed fit.
- b) The evaluation of financial bid will be done & price bids through e-procurement only. Eligible bid carrying lowest offer will be awarded the work. However, RECPDCL reserve the right conduct e-RA, at its own discretion.
- c) The basis of evaluation shall be the price quoted in the financial bid. To further clarify, the evaluation would be based on total price taking into consideration all applicable taxes which shall be summed up for comparison and evaluation.
- d) If the first-round price quoted is same for two or more Bidders, then all the Bidders with same price shall be considered of equal rank/ standing in the order.
- e) All Bidders with same price shall be eligible for reverse auction round (provided their rank is equal to or less than nth Bidder
