

In view of above, vendors are requested to send their representative for studying the scope of work for the subject work. It is requested to submit your offer with complete scope of work and features to be provided in this scheme.

5. The following terms and condition may please be noted:

- a. **Penalty Towards late Completion Period :** In the event of failure by the contractor to complete the execution of work within stipulated period in the contract, the contractor shall pay to JNPT as liquidated damages @ 1% + applicable GST of total work order basic value per week or part thereof subject to maximum 5% + applicable GST of the work order basic value.
- b. **Term of Payment:** JNPT will effect payment within **30 days** after receipt of successful of completion of work report. Payment will be made through RTGS/ NEFT against submission of all original invoices with delivery challan, successful work completion report, Guarantee/ Warrantee Certificate and the RTGS/ NEFT to JNPT in the format provided by JNPT. Also, before commencement of work the contractor has to submit the B.G.
- c. **Performance Guarantee (PG):** The successful Tenderer will be required to furnish security deposit towards Performance Guarantee for **10% of** Contract price with GST within 21 days from the date of issue of letter of intent or work order as acceptance of the Tender by Demand Draft in favour of JNPT or in the form of Bank Guarantee, on any Nationalized / Scheduled Bank having its branch in Mumbai.

The performance guarantee submitted in the form of Bank Guarantee should be valid for a minimum period of **123 months** from the date of letter of acceptance or work order and the same has to be extended for a further period as required by JNPT. Any expenditure in this regard will be borne by the Contractor. The Proforma of Bank Guarantee for Performance Guarantee will be given to successful tenderer.
