### **31) EVALUATION OF UNPRICED BIDS**

The bids shall be evaluated on the basis of the following criteria:

31.1) Acceptance of Tender specifications, Drawing, Terms and condition.

31.2) Submission of delisting declaration.

31.3) Submission of other documents sought in unpriced bid.

31.4) **RECEIPT OF BID:** Bids received late i.e. after due date and time, due to any reason (s) whatsoever shall be rejected.

### **32) DEVIATIONS TO TENDER REQUIREMENTS:**
