I. COMPANY PROFILE

NHPC Limited was incorporated in 1975 under the Indian Company's Act, 1956 with an objective to become a world class, diversified and transnational organization for sustainable development of hyderoelectric power and water resources. NHPC has also diversified in the field of Solar and Wind Power. NHPC Limited is a schedule "A" Mini-Ratna CPSE in Power Sector with the administrative jursidiction of Ministry of Power.

Its Registered and Corporate offices are at Faridabad, Haryana.

The company employed 5569 regular employees (Executives: 3281, Non-executives: 2288) as on 31.03.2021.

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
