- Eligible Applicants and Qualifying Requirements:-The criteria for Eligibility of Applicants and Qualifying Requirements shall be as per Clause 2 & 3 of ITA (Section 2).

At any time before the submission of Proposals, HPPCL may modify/amend the RFP Document and extend the last date of submission/opening of the Proposal and any other key dates by issuing a corrigendum/addendum and such corrigendum/addendum to this notice as well as to the RFP Document shall be made available to the Applicants. Any Corrigendum/Addendum thus issued shall form part of RFP Document.

To give prospective applicants reasonable time to take cognizance of an addendum in preparing the proposals, the Employer shall extend, as necessary, the deadline for submission of proposals.

- Procedure for selection of successful applicant:- HPPCL shall award the consultancy assignment to the applicant meeting the eligibility and qualifying requirements and who has quoted the least amount. Detailed procedure shall be as defined in ITA (Section 2).
- The proposals submitted by the applicants shall remain valid for acceptance for a period of One hundred twenty (120) days from the date of opening of proposals.
- Successful applicant will have to submit PAN and GST no.(if applicable) from the respective authorities as per statutory rules and regulation on issuance of LOA.
- Employer reserves the right to cancel the tendering process at any time before award of work.
