IN THE MATTER OF:

Application for Determination of True-Up for FY 2020-21, Annual Performance Review (APR) for FY 2021-22 and Annual Revenue Requirement (ARR) for the FY 2022-23-(Petition No.-1797/2021) of Noida Power Company Limited (NPCL), Greater Noida.

ORDER

As per provisions of Section 64 of the Electricity Act, 2003, it is incumbent upon the Licensee to make an application to the State Electricity Regulatory Commission for determination of Tariff in such manner as may be specified by the Commission as per the applicable Regulations.

The Uttar Pradesh Electricity Regulatory Commission (Multi Year Tariff for Distribution and Transmission) Regulations, 2019 (hereinafter referred as 'MYT Regulations, 2019') were notified on September 23, 2019. These Regulations are applicable for determination of Tariff in all cases covered under these Regulations from April 1, 2020, to March 31, 2025, unless otherwise extended by the Commission.

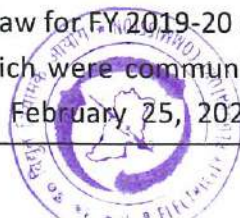
As per the provisions stipulated in the Regulation 4 of MYT Regulations, 2019, the Petition for determination of True-Up, Annual Performance Review (APR) and Aggregate Revenue Requirement (ARR) / Tariff, complete in all respect have to be filed by the Distribution Licensee for each year of the Control Period (FY 2020-21 to FY 2020-25) before the Commission on or before November 30 of each year.

Further, Noida Power Company Limited (hereinafter referred to as 'NPCL' / 'Petitioner'), filed Petition before the Commission on November 26, 2021, for determination of True-Up for FY 2020-21, APR for FY 2021-22 and ARR & Tariff for FY 2022-23.

A preliminary analysis was conducted, wherein the Commission asked the Petitioner to submit reconciled power purchase cost with the audited account, scheme wise capex details, detailed evidence for the variance in depreciation, the complete details as per the additional formats provided by the Commission, impact of additional coal for FY 2020-21 of Dhariwal Infrastructure Limited (DIL) and impact of change in law for FY 2019-20 and FY 2020-21 of DIL along with various other deficiencies observed, which were communicated vide its letters dated December 31, 2021, February 9, 2022 and February 25, 2022 respectively.
