- 2. Tender online will be opened at **10:30** a.m. on **02/05/2022** in the office of the V. P. Telaulim Salcete Goa.

Further, the only one application should accompany the following documents (Scan & Upload on the e-Tender website):

- 1. Attested copy of valid Registration Certificate with GEDA
- 2. Attested copy of PAN Card.
- 3. Attested copy of GST Registration.
- 4. Mode of Payment towards Cost of the Tender Document, EMD & Tender Processing Fee: To be paid online through e-payment mode via NEFT/RTGS/net banking with pre-printed challans available on e-tendering website and directly credit the amount to ITG account as generated by challans for NEFT/RTGS.
- 5. The applicant should upload the scanned copy of the declaration in prescribed format (Annexure –A) giving the names of the works in hand in the above mentioned category on stamp paper of Rs. 50/-.
- 6. The contractors having four or more works in hand in the same category in their name of firm need not apply such applications will be rejected.

INSTRUCTIONS TO DISTRIBUTORS / DEALERS

- 1. The intending bidder must read the terms and conditions carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 2. Information and Instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website https://eprocure.goa.gov.in
- 4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- 5. The intending bidder must have / obtain a valid Class-III digital signature to submit the bid.

- 6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 7. Bidder must ensure to quote rate of each item.
- 8. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender & will be rejected outright. Also name of the bidder should be entered in respective cell.
- 9. The tenderer shall be responsible for the correctness and genuine of the documents uploaded during tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
- 10. No Hardcopies of the documents to be submitted in the tender box.
- 11. Bidder should be a Registered with Goa Energy Development Agency Goa as an Integrator for Rooftop Solar Power Plants.
- 12. Bidder if registered with MSME shall be exempted from EMD
- 13. EMD exemption should be made available in the tender document online selection option.
- 14. EMD equivalent to 2% of the quoted amount shall be submitted for the Group-I & Group II.
- 15. Tender without requisite amount of EMD shall be out rightly rejected. Correspondence on request from any bidder on exemption of EMD will not be entertained by the Panchayat. The units functioning in Goa and registered / acknowledge under the certificates of MSMEs i e. EMD/Udyog, Aadhar / Udyam Registration are eligible for the exemption of EMD under the Preferential Purchase Incentives for Micro and Small Enterprises Scheme 2008 of Goa Government and its amendments from time to time.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
