1.0 NTPC Limited (NTPC) invites online bids on "Single Stage Two Envelope Bidding Basis" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

#### 2.0 BRIEF SCOPE OF WORK

The scope of the proposal for Supply, Installation, testing and commissioning of 02 nos 30Kwp and 5 nos, 10 Kwp each roof top PV Solar plant at NTPC Auraiya shall be on the basis of single point responsibility completely covering the activities and services in respect of all the equipment & works specified and covered under the specifications and read in conjunction with "Scope of Supply & services" elaborated elsewhere.

3.0 Detailed Specification, Scope of Work and Terms & Conditions are given in the Bidding Documents, which are available for examination and Sale at our eProcurement Portal (https://eprocurentpc.nic.in/nicgep/app) and as per the following schedule:

- 4.0 All bids must be accompanied by **EMD** as stipulated in the Bidding documents.
- 5.0 Bidder has to ensure the following documents to be submitted online, pursuant to ITB Clause 15, failing which bid is liable for rejection
  - a) Tender Fee: As applicable, Tender fee shall be submitted online through GePNIC Portal.
  - b) Earnest Money Deposit: As applicable., EMD shall be submitted through online option on GePNIC Portal. EMD Exemption is not allowed being Works Contract.
  - c) Integrity Pact: Not Applicable
- 6.0 A complete set of Bidding Document may be downloaded by any interested Bidder from <a href="https://eprocurentpc.nic.in/nicgep/app">https://eprocurentpc.nic.in/nicgep/app</a>. Tender fee, as mentioned above before stipulated date & time of submission of bid.

#### 7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following Qualifying Requirements.

## 1.0Technical Criteria:

The Bidder should have executed similar work(s) within the preceding seven (7) years prior to the date of techno-commercial bid opening, meeting the following criteria:

(i) Single order having executed value of above work(s) not less than Rs. 43 Lakh.

OR

(ii)Two orders having executed value of above work(s) not less than Rs. 27 Lakh each.

OR

(iii)Three orders having executed value of above work(s) not less than Rs. 21 Lakh each.

Similar works means: a) The Bidder should have designed, supplied, "erected/ supervised erection" and "commissioned/ supervised

commissioning" of Solar Photo Voltaic (SPV) based grid connected power plant (s) of cumulative installed capacity of "90 KWp or higher", out of which at least one plant should have been of "30 KWp or higher capacity". The reference plant of "30 KWp or higher capacity" should have been in successful operation for at least six (6) months prior to the date of techno commercial bid opening.

## OR

b) The Bidder should be a developer of Solar Photo Voltaic (SPV) based grid connected power plant(s) of cumulative installed capacity of 90 KWp or higher, out of which at least one plant should have been of 30 KWp or higher capacity. The reference plant of 30 KWp or higher capacity should have been in successful operation for at least six (6) months prior to the date of techno commercial bid opening.

## Note:

- 1. The reference SPV based grid connected power plant should be at a single location developed by Bidder for itself or any other client.
- 2. SPV based Roof-top, which are grid connected, shall also be considered eligible for QR purposes.
- 3. Projects executed by Bidder's group company, Holding Company or Subsidiary Company shall also be considered as Bidder's experience for meeting the QR, provided Bidder is an Indian company registered in India.
- 4. The Bidder shall also be considered qualified, in case the award for executing the reference works has been received by the Bidder either directly from owner of plant or any other intermediary organization. A certificate from such owner of plant or any other intermediary organisation shall be required to be furnished by the Bidder along with its Techno-Commercial bid in support of the Bidder's claim of meeting the qualification requirement above. Further, certificate from owner of the plant shall also be furnished by the Bidder along with the Techno-Commercial bid for the successful operation as specified above.
- 5. Developer means an entity who has either executed or got executed the work/ project as owner.
- 6. In case of developer as Bidder in clause b, the documentary evidence

(certified by Chartered Accountant) for value of executed reference work must be submitted by the Bidder.

## 2.0 Financial Criteria

2.1 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than Rs. 54 Lakh (Rs. Fifty-Four Lakh only).

In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award. In case the bidder is not able to furnish its audited financial statements stand-alone entity basis. the unaudited on unconsolidated financial statements the bidder can of acceptable provided the bidder further furnishes the considered following documents for substantiation of its qualification.

- (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
- (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company.
- 2.2 In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the

financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

## NOTES:

- (i) Other income shall not be considered for arriving at annual turnover.
- (ii) "Holding Company" and "Subsidiary" shall have the meaning ascribed to them as per Companies Act of India.
- (iii) For Turnover indicated in foreign currency, the exchange rate as on seven (07) days prior to the date of techno-commercial bid opening shall be used.
- (iv) All financial figures mentioned above are exclusive of GST.

8.0 Only Class-I & Class-II local suppliers are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

Bids received (if any) for specified item(s) from Non Local Supplier shall be considered non-responsive and shall not be evaluated in respect of such item(s).

The local content requirement to categorize a Bidder/ Supplier as 'Class-I local supplier' is minimum 50%. For Class-II local suppliers, minimum local content is 20%.

#### Note:

- i. The bidder has to furnish declaration regarding local content in Employer's attached format for availing purchase preference. The duly filled-in declaration format is to be submitted in *TECHNO-COMMERCIAL BID COVER/ ENVELOPE*.
- ii. Also supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make In India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)".
- iii. In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

9.0 The Contractor shall not be allowed to sub-contract works to any sub-contractor/ sub-vendor from a country which shares a land border with India unless such sub-contractor is registered with the competent Authority.

The Competent Authority for the purpose of registration shall be as mentioned in the **Annexure - II** of SCC.

However, the said requirement of registration will not apply to sub-contractors from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects. The Contractor may apprise itself of the updated lists of such countries available in the website of the Ministry of External Affairs.

- 10.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 11.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 12.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
