- (6) Bidders intending to participate in the Tender are required to get themselves trained on the e-Procurement System.
- (7) The required amount of EMD shall be accepted through online payment only. The Bidders are required to invariably upload the valid documentary evidence of submission of online EMD in Cover-1 without which online offer i.e., Cover- 2 & 3 shall not be opened.
- (8) No offer will be accepted without valid Earnest Money Deposit. If on opening of tender, it is revealed that EMD amount is inadequate / any other discrepancy is noticed, the tender shall be rejected and returned to the tenderer.

- (13) The Pre-bid meeting will be held on 13-04.2022 at 12:00 Hrs at the office of CGM (Purchase), Block No.8, Shakti Bhawan, Jabalpur.
- (14) The Ministry of New and Renewable Energy, Government of India (MNRE) is implementing Phase-II of Grid Connected Rooftop Solar (GCRTS) Programme wherein central financial assistance (CFA) is being provided for installation of rooftop solar (RTS) projects in residential buildings. To implement the RTS activities in respect of the aforesaid programme, respective Power Distribution Companies (DISCOMs) have been designated as the implementing agency. Government of Madhya Pradesh has decided that Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited, Jabalpur shall be the tendering agency for jurisdiction / operational area of Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited and will identify L-1 rates and empanel vendors for implementation of the programme. MPPoKVVCL will execute RTS projects in their operational areas through the empanelled vendors, in accordance with the rates discovered in this tender.

- (15) Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited invites e-bids from eligible bidders to participate in Request for Selection (RFS) for empanelment of vendors for Site Survey, Design, Installation, Supply, Erection, Testing and Commissioning including Warranty and 5 years of Comprehensive Operation and Maintenance of Roof Top Solar PV Power System for Residential Consumers in the jurisdiction / operational area of Madhya Pradesh Poorv Kshetra Vidyut Vitaran Company Limited. This RFS shall be governed by terms of sanction received from MNRE vide No.318/63/2019-GCRT dated 19.01.2022 for MPPKVVCL, Indore.
- (16) For the implementation of above-mentioned work, Bidders should submit their bid proposal online, complete in all aspect, on or before Last date of Bid Submission as mentioned on the Bid Information Sheet.
- (17) Bidder shall submit bid proposal along with non-refundable bid processing fee (Tender Fee) and refundable Bid Bond (EMD) as per the Bid Information Sheet. Techno-Commercial bids will be opened online as per the Bid Information Sheet in presence of authorized representatives of bidders who wish to be present online. Bid proposals received without the prescribed bid processing fees and Bid Bond (EMD) shall automatically be rejected. In the event of any date mentioned in bid information is declared a Holiday, the next working day shall become operative for the respective purpose mentioned herein.
