KEC International wins New Orders of Rs. 945 crores

Mumbai, April 05, 2022: KEC International Ltd., a global infrastructure EPC major, an RPG Group Company, has secured new orders of **Rs. 945 crores** across its various businesses:

Transmission & Distribution (T&D):

The business has secured orders for T&D and Cabling projects in India, SAARC, Middle East, and Americas:

- 765 kV GIS Substation order in India, from Power Grid Corporation of India Limited (PGCIL), under Tariff Based Competitive Bidding (TBCB) route
