Bidders are required to register themselves online with M/s ISN Electronic Tender Services website <https://www.bharat-electronictender.com> (if not registered already) e-tender portal, through the payment gateway facility of the e-bidding portal of INR 3000 (Indian Rupees Three Thousand) (plus applicable taxes as indicated in E Tender portal) and subsequently download the RfS and other Bid Documents from the E-tender Portal. A Bidder, who is already registered on the E-tender Portal need not register again on the E-tender Portal. Additionally, prior to submission of the proposal, a bidder is required to pay online through the payment gateway on the E-bidding portal) a non-refundable ETS bidding/ Reverse Auction fee of INR 15,000 (Indian Rupees Fifteen Thousand only) (plus applicable taxes as indicated in the e-bidding portal).
