Notes to Bidders

1. This tender enquiry is being floated for finalizing vendor to carry out rectification of Solar Inverter and allied jobs at MCC Room at HPCL, Mangalore POL Terminal.
2. **Background:**

HPCL is a Fortune 500 corporation involved in refining and marketing of petroleum products. HPCL is having many installations as part of infrastructure for distribution of petroleum products. Mangalore POL Terminal is one of the prime installation for filling of both white oil and black oils to tank trucks and tank wagons.

MCC-Motor Control Centre situated inside the premises of Mangalore POL terminal. It is proposed to provide Roofing sheet structure assembly along with rainwater collection facility for MCC building be required to protect from water ingress due to monsoon & climatic conditions
3. All the items shall be supplied, if applicable, conforming to the specifications as mentioned in the technical specifications provided in the tender document.
4. All the works/ services shall be done/ provided conforming to the scope of job as mentioned in the relevant sections in the tender document.
5. All the designs shall be made considering the relevant industry standards and practices to the scope envisaged in the tender as also the relevant national and international codes.
6. The bidder is strongly advised to understand the scope of job by detailed perusal of tender document. Bidder is also advised to visit and examine the site of works and its surroundings and obtain for himself on his own responsibility all information that may be necessary for preparing the bid and entering into the contract. The cost of visiting the site shall be at bidder's own expenses. No extra claim on account of non-familiarity of site conditions shall be entertained during execution of works.
7. The bidder and any of his personnel or agents will be granted permission by the Owner to enter upon his premises and lands for the purpose of such inspection, but only upon the explicit condition that the bidder, his personnel or agents will release and indemnify the Owner and his personnel and agents from and against all liability in respect thereof and will be responsible for personal injury (whether fatal or otherwise), loss of or damage and expenses incurred as a result hereof.
8. Bidders shall examine the bid document thoroughly and submit to HPCL any apparent conflict, discrepancy or error. HPCL shall issue appropriate clarifications or amendments, if required. Any failure by Bidder to comply with the aforesaid shall not excuse the Bidder from performing the services in accordance with the contract if subsequently awarded.
9. Deviations, if any, shall be indicated clearly and shall be attached along with the unpriced bid of the tender. Any other attachments which the bidder would like to attach (eg: previous work orders/ authorized dealer certificates etc.) can be attached along with the unpriced bid.
10. Notwithstanding the subdivision of the document into these separate sections and volumes, every part of each shall be deemed to be supplementary to and complementary of every other part and shall be read with and into the Contract in so far as it may be practicable to do so.
