- 1.0 The following relevant essential documents shall be uploaded for Technical Bid Evaluation (as applicable for works mentioned in 'List of Works' as above.
- 1.1 **Proof of relevant experience** of having successfully completed similar natured works, as a whole [The work shall be completed as a whole. Partial value / partial completion certificates shall not be considered].

Such similar works completed during the last 7 years, ending last day of the month previous to the date of this tender notice, shall be one of the following [In case if the experience certificate obtained is from any Reputed / Private Organization, the same shall be supported with TDS certificate for the relevant period].

a) **Three** similar completed works each costing not less than an amount equal to **40%** of estimated value mentioned above in the tender notice.

Or

b) **Two** similar completed works each costing not less than an amount equal to **50%** of estimated value mentioned above in the tender notice.

Or

c) One similar completed works each costing not less than an amount equal to 80% of estimated value mentioned above in the tender notice.

<u>Similar Works means "Similar Works means:</u> "<u>Supply and installation/repair of solar PV system</u>" shall be considered as similar works for this work.

- <u>Note 1</u>:I) Copy of Work order / acceptance letter / agreement / work progress certificate shall not be accepted as experience.
- II) Each completion certificate furnished shall be against works completed/executed under one single Work order. Single experience certificate specifying the value of works executed under various work orders as one work shall not be considered.
- III) The tenderer has to produce copy of Work order, BOQ or any such relevant document in support of the experience certificate, solvency or any other credential furnished/uploaded, along with the originals of the same for verification (the originals will be returned subsequently), as and when sought by HAL, Hyderabad.
- 1.2 Average of Annual Financial Turnovers [AAFT] issued by auditors during the last 3 years, ending financial year 2021, should be at least 30% of estimated cost of this contract.
- 1.3 Latest Banker's Solvency (should be at least 40% of estimated cost of this contract not older than 12 months from the final date of submission of tender) for a minimum amount as mentioned in column [5] from any Nationalized / Scheduled bank.
- 1.4 **ESI/PF**: The contractors are required to comply with the provisions of ESI & PF act. The contractor shall be required to Indemnify HAL for any liabilities arising on account of ESI & PF act as per the Proforma D and same to be included in the tender document
- 1.5 PAN /GIR No. Registration Certificate issued by the Income Tax Authority.
- 1.6 Certificate of GSTIN Number.

- 1.11 Cost of tender document (Non-Refundable): The cost as specified at column [8] of the above table to be submitted in the form of DD / bankers cheque drawn in favor of "M/s. HAL, Hyderabad" payable at Hyderabad to be submitted to the address mentioned below so as to reach by post / courier/ by hand latest by 1400 Hrs of the "due date of online submission of tenders". However the details of DD No. date etc., to be provided in the prequalification profile and also the scanned image of the same is to be uploaded. Deposit through any other form will not be accepted. Tenderers having UDYAM certificate and claiming exemption from submission of cost of tender document are requested to abide by the conditions laid down at Para -4 of NIT.
- 1.12 Earnest Money Deposit: Earnest Money Deposit as specified at column [4] of the above table to be furnished in the form of Demand Draft / Bankers cheque drawn in favor of "M/s. HAL, Hyderabad" payable at Hyderabad, from a Nationalized Bank / Scheduled Bank. Deposit through any other form will not be accepted. EMD deposited by the tenderer shall not bear any interest to the contractor. The scanned image of earnest money deposit to be uploaded online along with the tenders and the original one to be submitted to the address mentioned below so as to reach by post / courier / by hand latest by 14:00 Hrs of the "due date of online submission of tenders". However the details of DD no date etc. to be provided in the prequalification profile. The cost of tender document and EMD to reach the following address by post / courier / by hand up to 14:00 Hrs on the "due date of online submission of tenders" as mentioned in the tender notice failing which tender will not be considered/opened and any postal delay or any other reasons what so ever will not be considered. The EMD will be refunded to the un-successful tenderers, unless the same is forfeited to the Company for any breach on his part. If the tender is accepted, the Earnest Money will be converted into Security Deposit as stipulated. If the EMD is paid less than the EMD prescribed in the tender documents, the tender will be liable for rejection.

- **1.13** Undertaking from the bidder duly filled & signed to be submitted for indemnifying HAL, Hyderabad against all the statutory requirement of the Concerned Statutory authorities. (Undertaking as per formats Proforma C & D enclosed). A scanned copy of the same to be uploaded as a token of having understood the statutory requirements, work content, specifications, terms and conditions of the tender. The Successful bidder shall submit PF registration certificate before the commencement of work and shall comply with all the requirements as per PF act, failing which, the work order shall be cancelled. The service contracts involving labour supply shall be awarded only to the agencies having their own ESI code.
- 1.14 Any bidder from a country which shares a land border with India and the Government of India has not extended lines of credit or in which the Government of India has not engaged in development projects is not eligible to bid any procurement (i.e. goods, services & works). However, the bidders from that country are eligible only if the bidder is register with the Competent Authority (i.e. the registration committee constituted by the Department for Promotion of Industry and Internal Trade (DPIIT). (Note: The information on countries having Lines of Credit notified by Ministry of External Affairs (MEA) is available at http://meacms.mea.gov.in/list-of-countries-loc-extended.html. However, this aspect has to be confirmed by the Bidder by Submitting the Declaration certificate i.e. whether bidder is Type-I or Type-II as per Annexure –IIA, IIB after carefully reading clauses of at Annexure –I.
- 1.15 CONFIDENTIALITY: For the purpose of this Tender/ Contract/ Agreement, the Bidder/ Contractor/ Supplier shall not store, copy or disclose HAL's data and information whether in written, machine readable or other tangible form or disclosed orally, that is of value to HAL. Also, Bidder/ Contractor/ Supplier agree to use HAL's data only for purpose under this Tender/ Contract/ Agreement, restrict disclosure to any other person or entity or third party and shall safeguard the provide data including from cyber security risks etc. Bidder/Contractor/Supplier should promptly return within 90days HAL's data in original media and should not keep HAL's data, upon expiry of Tender/ Contractor/ Agreement or early termination of Contract/ Agreement and certify that HAL's data has been deleted permanently.

Non-adherence to this confidentiality clause by the Bidder/ Contractor/ Supplier shall be treated, as a material breach of this Tender/ Contractor/ Agreement.

The provision of this clause shall survive and remain in force notwithstanding the termination or expiry of this Contractor/ Agreement.

1.16 Filled in pre-qualification profile form.

<u>Note-2:</u> The Successful bidder is required to comply with all the provisions of ESI Act / PF Act. The Successful bidder shall submit PF registration certificate before the commencement of work and shall comply with all the requirements as per PF act, failing which, the work order shall be cancelled.

The successful bidder/contractor shall engage only such workers who possess UAN & PF numbers. The Contractor shall get the UAN activated and ensure that the workers can get their E-pass books to know the PF balance in their account. The Contractor shall mention the PF account number and UAN number on the gate pass /I dentity card of each engaged worker.

The contractor shall, along with the bills, enclose the relevant ECRs for the PF remittances made, along with wage/salary register and attendance register for verification by HAL for release of payments, failing which, the work order shall be cancelled.

In addition to the above, the Contractor shall indemnify HAL for any liabilities arising on account of the provisions of ESI & PF acts and their subsequent amendments, if any, from time to time and shall undertake the same in Proforma - D.

Note-3: Tenders of those who fulfill the criteria mentioned at Clause 1.0 above will only be considered for further evaluation for the works at Sl.no. 1 in 'List of Works'.

2.0 General Instructions:
