**ORDER**

**(Date of Hearing - 21.04.2022)**

1. AHPCL has filed this Petition for approval of provisional tariff for FY 2022-23 as the MYT Petition for 2019-24 is pending before disposal of the Petition along with other related Petitions of Change in law filed by AHPCL and Review Petition of True-up Order of the Commission for FY 2014-19 filed by UPPCL.




2. The Petitioner has made following Prayers:

- a. Approve the Provisional Tariff to be paid with effect from 01.04.2022 onwards till such time the MYT orders for the Control Period FY 2019-24 are approved;
- b. To consider Rs. 718.62 Crores as AFC, Design Energy of 1251.94 MU and NAPAF at 43.31% that were approved by this Hon'ble Commission in its order dated 17.05.2021 in Petition No. 1693 of 2021, for determining the Provisional Tariff for Tariff Year FY 2022-23;

The Matter came up for hearing today.

3. Shri. Divyanshu Bhatt, Counsel, UPPCL submitted that they would like to place their submissions on the matter of NAPAF for FY 2022-23 and requested the Commission two-weeks' time for submitting the same. Shri Prasanna Reddy, Representative, AHPCL submitted that they would require one week time to file the rejoinder to the submissions of UPPCL.
4. After hearing both the parties, the Commission granted two-weeks' time to the Respondent for filing their submissions on the issue of NAPAF and one week time thereafter to the Petitioner for submitting a rejoinder towards the submissions made by the Respondent.
5. The Commission has noted that AHPCL has sought continuation of existing tariff of FY 2021-22. UPPCL has no objection to the same. Accordingly, The Commission directs the Petitioner to raise invoice for FY 2022-23 in terms of the existing tariff fixed for FY 2021-22 till the disposal of the current Petition.
