Procedure to submit tender:

- 1) The tender document should be submitted as follows.
 - * Cover-1 shall contain the techno-commercial bid (Page 1 to 37) and all other relevant documents.
 - * Cover-2 shall contain only a price bid. (Part II Page no.38).

Scope of Work:

Comprehensive AMC of 10 Nos of Solar inverter (Model-Hiverter NP201i) at BHEL, Ranipet

- 1. Vendor should depute service engineers for Preventive maintenance of Solar Inverter once in 3 months. The routine maintenance / check-up of each inverter shall be carried out during the visits.
- 2. Apart from routine maintenance visits, Vendor should also serve during Emergency/ breakdown/on-rush; this will be unlimited number of Services during this CAMC period. Time line to report at site for this emergency service will be 48 hour from receipt of service call reporting. Emergency service call will be registered through supplier given mail ID / Phone.
- 3. After completion of routine CAMC work, contractor's service engineer should verify inverter operation in presence of BHEL representative.
- 4. Contractor deputed service engineer should guide & educate BHEL representative for basic operation & alarms verification and corrections. And also, guide to take all precautionary measures to improve product life.
- 5. Any violation during CAMC will be reviewed mutually for better execution
- 6. Vendor should maintain Mandatory spares at nearest location / nearest branch office, in that case material delivery time should be within 48 hours.
- 7. Any external factors affecting like natural calamity, FIRE, failure due to short circuit, total black out etc. will come under force majeure clause and not considered in CAMC.
- 8. During CAMC period, On logging complaints, the contractor has to send a qualified service engineer to attend the breakdown calls. If the contractor does not complete a minor breakdown work within Two BHEL working Days and Major Breakdown within Four BHEL working days including holidays, Penalty will be imposed at the rate of ½% of the particular Annual BOQ value per week of delay and subject to a MAXIMUM ceiling of 10% of particular BOQ value. Any recovery will be done along with GST at applicable rate.
- 9. Any Special clause/ Condition of mutual agreeable
 - All force major and pandemic condition will be considered as natural calamities to avoid any dispute during CAMC terms. Same will be treated separately apart from CAMC terms

10. The CAMC of Solar Inverters will cover all items /works related to solar inverter operations except the following material replacement (if required) for operation of PCU. This will be done by BHEL.

Scope of BHEL:

- 2. BHEL will arrange work permit & equipment operation .
- 3. BHEL will provide internal transport, drinking water, lighting arrangement, any skilled/unskilled manpower during the visit of Vendor.

C) Termination of CAMC:

If the performance of the contractor is found not satisfactory. BHEL will terminate the CAMC contract within 15 days of notice period. After the expiry of such notice period this contract shall be terminated and no party shall be liable for any claims/liabilities arising out of acts/deeds/transactions done by other Party after such termination. However, the Parties shall remain liable for all acts/deeds/transitions undertaken or done before the date of termination of this contract.

BHEL reserves the right to reduce the contract period (pre-close the contract), with 30 day's notice period depends on the requirement / without assigning any reason.
