8. **Eligibility Criteria**
  - (A) **For MES Enlisted Contractors Class in MES Category of enlistment**
    - (a) All contractors enlisted with MES in **Class 'D' and above and category b (i)** shall be considered qualified provided they do not carry adverse remarks in WLR of competent engineer authority.
    - (b) Contractors shall submit the electric license, otherwise tender shall be rejected.
  - (B) **For other contractors**
    - (a) The firms not enlisted with MES shall meet the enlistment criteria of **'D'** class MES contractors & category **b (i)** i.e. with regard to having satisfactorily completed requisite value work, Annual turnover, solvency, working capital, immovable property/ fixed assets, T&P, Engineer establishment, no recovery outstanding in any Govt Department, Police verification/passport etc. Enlistment criteria may be seen in Para 1.4 & 1.5 section 1 of Part I of MES Manual on Contracts- 2007 (Reprint 2012) as available in all MES formation.
    - (b) These firms shall also submit copy of Police verification from police authority of the area where the registered office of the firm is located/ notarised copy of valid passport of proprietor/each partner/each Director
    - (c) They should not carry adverse remarks in WLR/or any other similar report of any authority.
  - (C) **For all Contractors**

Contractor will not be allowed to execute the work by subletting or through power of attorney holder on his behalf to a third party/other firm except sons/daughters of proprietor/partner/Director and firm's own employees Director, Project Manager. This shall be not subject to certain condition which will be prescribed in the NOT forming part of the tender documents

The unenlisted bidder shall required to sign the Bid declaration as below and submit in cover-1 on their letter head: " I/We hereby understand and accept that if I/we withdraw or modify my/our bids during the period of validity, or if I/We are awarded the contracts and on being called upon to submit the Performance security /Security deposit before the deadline defined in the request for Bid documents/Notice Inviting tender, (a) I/ We shall be debarred from the exemption of submitting Bid Security/Earnest Money Deposit for a period of 6 (Six) Months from the date I/We are declared disqualified from the exemption from submission of Earnest Money Deposit/Security Deposit, for all tenders issued by MES during this period. (b) I/We further agree and authorize MES to recover the sum equal to EMD from our dues outstanding from any other departments of Central Govt. or State Govt. /PSU's/ or from any other sources.

**Notes :**

- (i) Applications /bids not accompanied by scanned copies of requisite DD/ Bankers Cheque towards cost of tender and earnest money (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.
- (ii) Tenderers/bidders to note that they should ensure that their original DDs and earnest money (as applicable) are received within 05 days of bid submission end date.
- (iii) In case of applications /bids from enlisted contractors of MES, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motive and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.
- (iv) In case of applications/bids from unenlisted contractors, where scanned copies of requisite DD/ Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated dates, finance bids will not be opened. Name of such contractor along with complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
- (v) In case of applications/bids (enlisted contractor as well as unenlisted contractor) where scanned copies of requisite earnest Money (as applicable) where uploaded by the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.
- (c) Contractor enlisted with MES will upload following documents for checking eligibility:-
  - (i) Application for bid in firm's letter head.
  - (ii) Enlistment letter.
  - (iii) Scanned copy of DD of cost of tender.
  - (iv) Scanned copy of provident fund code number of the firm
  - (v) Scanned copy of GST (Goods and Services Tax) Registration Number of the firm

(d) Contractors not enlisted with MES will be required to upload necessary document to prove their eligibility in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in para 1.5 of section 1 of Part - I of MES Manual on contracts 2007 (reprint 2012). Following documents shall also be uploaded amongst others:-

(i) Details of three highest valued similar nature of works executed during last five years, financial year wise in tabular form giving name of work, Accepting Officer's details, viz Address, telephone, Fax No, E-mail ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor/all partners/authorized Director of Pvt/public Ltd as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client same shall also be submitted duly attested.

(ii) Solvency certificate and working capital certificate issued by Scheduled bank.

(iii) Annual turnover certificate for last 2 years issued by Chartered Accountant alongwith relevant pages of audited balance sheets in support thereof.

(iv) Affidavits for possession of movable & immovable properties by proprietor/partner owning the immovable property alongwith Valuation Certificate from Regd Valuer in support of movable & immovable properties. In case of Limited Company, the immovable property is required to be in the name of the Company.

(v) In addition, the un-enlisted contractors shall also furnish affidavit on Non Judicial stamp paper in the form of hard copy declaring their turnover for last 2 (two) years.

(vi) Scanned copy of DD of cost of tender and earnest money.

(vii) Scanned copy of provident fund code number of firm.

(viii) Scanned copy of GST (Goods and Services Tax) Registration Number of the firm.

(e) The tenderer shall upload their '**Goods and Service Tax Registration Number**' alongwith 'T' bid.

(f) **Court of the place from where tender has been issued shall alone have jurisdiction to decide any dispute out of or in respect of this tender. After acceptance of tender, Condition 72-Jurisdiction of courts of IAFW- 2249 shall be applicable.**

(g) In case of rejection of technical/ prequalification bid, contractor may appeal to next higher Engineer Authority i.e. Commander Works Engineer Mathura against rejection, whose decision shall be final and binding. However contractor/ bidder shall not be entitled to any compensation whatsoever for rejection of technical/ prequalification bid.
