3. Tenderers should possess **qualifications** as prescribed in Section 3 of NIT.

4. Tenders must be accompanied by **Earnest Money Deposit** which will be paid online as per Clause 13.

5. Tenders must be **electronically submitted** (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, at the Office of the Manager (Sub Contract). Tenderers shall also submit all the documents as per Part-I in original duly signed and sealed on or before the last date and time of receipt of tender in sealed cover at the office of Manager (Sub Contract)

6. The tenderer is requested to **submit queries**, if any, in writing or by cable to reach the employer not later than **--/--/2022**. The tenderer has to **visit the site** and assess the actual site condition, nature of work and quantum of work before quoting the work.

7. The rate quoted should be excluding GST and including all statutory levies, taxes, duties etc as applicable. The rate of GST and other levies shall be indicated separately in the covering letter. GST will be paid extra.

8. **Payment:** Being PMC work payment shall be released against receipt of same from client.
