## 1.2 ELIGIBILITY CRITERIA

a) As per GOI Order No. P-45021/2/2017- PP(BE-II), dated 16-09-2020 for Make in India only [Class I local supplier if local capacity exists]/[Class-I local supplier & Class-II local supplier if local capacity doesn't exist and value of work is less than 200 crores] are eligible to bid for this EOI [not applicable for global EOIs or if approval has been taken from Competent Authority.].

(Mandatory Undertaking for Purchase Preference to MAKE In INDIA to be submitted along with this EOI. The bidder needs to submit calculation of local content as per format attached in Section-11. The detailed clause is mentioned at Clause 2.3 in Section-2 of this EOI and the documents required for verification of local content needs to be submitted as per this Clause.)

- b) The bidder / OEM should be an Indian Registered Company under Companies Act 1956 or 2013/ Proprietorship /Partnership Firm. Copy of Certificate of Incorporation/ Registration/ Partnership Deed or any other relevant document, as applicable, should be submitted along with a copy of address proof.
- c) The bidder /OEM shall fulfill the following financial criteria:
  - i. Average Annual Financial Turnover during the last 7 years, ending 31st March of the previous financial year should be at least 1.47 Crs (1.22 Crs for Micro and Small Enterprises (MSEs) & Startups) excluding GST.
  - ii. Net worth should be positive as on 31<sup>st</sup> March of last Financial Year.
  - iii. The bidder should be in profit before tax (PBT) in two out of last three financial years.
- d) Experience of having successfully completed similar works/supplies during the last 3 years from the date of bid submission should be either of the following:
  - i. On-Grid Solar PV projects The Value of the works shall be minimum
    - a. Three contracts of each not less than 1.96 Cr. of the estimated cost of the project.

b. Two contracts of each not less than 2.45 Cr. of the estimated cost of the project.

c. One Contract of not less than 3.92 Cr. of the estimated cost of the project.

'Similar work' implies the Bidder On-Grid Solar PV projects executed/completed with any Central/State Govt. Department / Public Sector Undertaking / Urban Local Bodies during last five financial years stating Name of work, Name of Department worked with, Cost of completion, Date of Completion duly certified by the employer. The certificate to that effect has to be obtained from an officer not below the rank of Executive Engineer/Project Manager concerned with the work. One Similar Work means a Single Work/Purchase Order of value as given in this clause above.

The bidder should submit supporting document i.e. work order and completion certificate from client.

- ii. Bidder is required to sign a MoU with agencies associated with him for execution of specialized components like Electrical & IT Works etc eg. for IT works, the contractor needs to enter into an MoU with the IT contractor of appropriate class (as per requirements of client RFP)
- iii. The bidder / Contractor should be registered under unified registration in CPWD with a valid UIN Equivalent Registration in any State Govt. Dept. Central Govt. Dept., other Govt. Dept. / undertaking of state/Central Govt. P.S.U
- e) The bidder should have a valid PAN and GST Registration (copy of PAN card and GST Registration certificate should be submitted in the bid).
