The bidder shall meet the following PQ requirements.

### **Pre-Qualification Requirements**

The bidder should satisfy the following pre-qualification requirements on the date of submission of bid.

- (i) The bidder should have minimum annual turnover of Rs. 2.48 Lakhs during the last three years ending 31<sup>st</sup> March of the previous Financial Year.
- (ii) The bidders, during last seven years, immediate preceding to Financial year ending March 2022, should have successfully executed similar works of value as under:
  - a) Three similar completed work each costing not less than Rs. 3.30 Lakhs.  
or
  - b) Two similar completed work each working not less than Rs. 4.13 Lakhs.  
or
  - c) One similar completed work costing not less than Rs. 6.61 Lakhs.

Similar work is defined as experience of Installation or providing Annual Maintenance Contract for Grid connected between 100 KWp to 500 KWp roof top solar photovoltaic (SPV) power plants

Note: Experience certificates issued by the private firms/company etc. must be supported with the TDS Certificates. Otherwise the certificate of Private Firms/company will not be valid.

(iii) Bidder is required to submit EPF details, GST, PAN etc.

Bidders are required to upload scan copies, documentary evidence in support of above PQ requirements accordingly.

1. Tenders are invited in two part bid system. Part-I (Techno Commercial Bid) and Part-II (Price Bid). Part-I shall contain Documentary evidence in support of tender fee and Technical specifications etc. which will be opened on the date mentioned in the bidding documents. Part-II shall contain only the price.
2. Techno commercial bid (Part-I) shall be opened on i.e. **02.09.2022** at 15.00 Hrs in presence of bidders who wish to attend the opening.
3. The bidders are requested to download the detailed NIT & the entire bidding documents from website <https://eprocure.gov.in/eprocure/app> from 15:00 Hrs. on 02.08.2022 to 15:00 Hrs. on 01.09.2022 The bidders can upload their bid on <https://eprocure.gov.in/eprocure/app> after vendor registration on line. Any Clarification/Corrigendum/Amendment shall be hosted in our web site <https://eprocure.gov.in/eprocure/app> only.
4. The bid shall remain valid for 120 days from the date of opening of bids.
  - i. Bids without tender cost & E.M.D. (Earnest money deposit) will not be entertained and proof of the same must reach at our office before opening of PQ & Techno-commercial bid. **However, as per the Govt. Guidelines, if the applicant is registered as Micro and Small Enterprises, the cost of tender fee and EMD will not be applicable. However, the proof for the same shall be submitted for eligibility. Without authentic proof of registration as Micro and Small enterprises, bid shall be treated as without tender fee and EMD.**

## **5. PREFERENCE TO MAKE IN INDIA**

Only 'Class-I Local suppliers' are eligible to participate in this empanelment tender, as defined, as defined in the attached **Annexure-VIII** (Preference to Make in India and granting of Purchase preference to local suppliers) to the bidding documents/Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT dated 16.09.2020. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

## **6. RESTRICTIONS ON PROCUREMENT FROM A BIDDER OF A COUNTRY WHICH SHARES A LAND BORDER WITH INDIA"**

Any Bidder from a country which shares a land border with India, as specified in the order (Public Procurement No.1) of Ministry of Finance, Department of Expenditure, Public Procurement Division vide Ref No. F. No.6/18/2019-PPD dated 23.07.2020 will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the above order. However, the said requirement of registration will not apply to bidder from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

Bidder shall certify duly signed and stamped **Annexure-IX** (enclosed) confirming that the Bidder fully complies with “**Restriction on Procurement from a Bidder of a country which shares a land border with India**”, which shall be submitted/uploaded along with Bid/Application.

Bidder’s failure to comply with the aforesaid requirement regarding submission of “**Annexure-IX**” may lead to rejection of the bid is enclosed. In case aforesaid certificate furnished by bidder is not in line with the declaration in respect of Local Content in their bid, same shall be treated as false declaration.
