question the decision of the Government or to challenge the validity of such decision.

iv. It is an ongoing scheme, however it may be reviewed after the awards for the Calender Year 2024 for better implementation.

14. Right to relax the scheme:

If it is necessary or expedient in the opinion of the Central Government to do so, documenting the reason for it, any of the provisions of these regulations may be relaxed by issuing an order.
