**ORDER**  
**(Date of Hearing - 02.08.2022)**

1. Pursuant to the last hearing dated 05.07.2022, Commission vide Order dated 20.07.2022 allowed the request of the Petitioner to adjourn the hearing and granted to two weeks' time to file an amended Petition with a copy to the Respondents. UPJVNL has filed the amended Petition on 15.07.2022 and UPPCL has filed its reply on 01.08.2022.

The matter came up for hearing today.

2. During the Proceedings, Shri Syed Saif Naqvi, Consultant for UPJVNL submitted that in compliance to the Commission Order dated 20.07.2022, they have filed the amended petition for determination of tariff for the FY 2019-24. However, since UPPCL has filed its reply on yesterday, they sought three-week time to file its rejoinder to the same.
3. The Commission observed that the MPPMCL's address is required to be updated since the last order sent has been returned as the mentioned address was incorrect. Sh. Naqvi responded that since the Matatila HPS & Rihand HPS has been excluded and therefore, order may not require to be sent. The Commission observed that in amended and original Petition MPPMCL remains a party, therefore, it is necessary to provide an opportunity for MPPMCL to put their response in the matter. Sh. Naqvi stated that they would update the MPPMCL's address before the Commission.

4. Further, Sh. Naqvi stated that since the transfer scheme has not been finalised by the U.P Government and therefore, true-up petition for the period 2009-14 & 2014-19 has not been filed by them.
5. Sh. Deepak Raizada of UPPCL submitted that they have no objection to the request of the UPJVNL.
6. After hearing UPJVNL, the Commission allowed the request of the Petitioner to adjourn the hearing. Further, the Commission granted three-weeks' time to the Petitioner to file their rejoinder to the UPPCL's reply.
7. The Commission also directs UPJVNL to update the address as well as memo of parties in the matter.
