- Online e-tenders in Single Cover System (Technical Bid & Price Bid in single cover) are invited from the tenderers for the work of "Design, Supply, Installation, Testing and Commissioning (DSITC) of solar system under Corporate Environmental Responsibility (CER) at Tahsildar Office, Uran." as per given specifications in the tender. The offered items shall conform to specifications given in this Tender document. The proposals shall be submitted in accordance with the instructions to the tenderers as enumerated in the tender document.
- 2. The estimated basic cost of the work is Rs. 3,27,400/- excluding GST. Total cost of estimate is Rs. 3,86,332/- inclusive of GST @ 18%. Completed e-tender shall be submitted by "ON-LINE" process on or before 28/09/2022 up to 1700 hrs. - **3. Minimum Qualifying Criteria:** The tenderer must fulfill the following qualifying requirement to consider for evaluation of tender and award of contract:
- i. The tenderer should have successfully completed similar work/s i.e. "Replacement/Shifting/Supply, installation, testing and commissioning of Solar PV plant with rail & clamps, ACDB, earthing & LA protection, remote monitoring during the last 07 (seven) years ending on the last day of month previous to the one in which tenders are invited, shall be any of the following:
 - Three completed works each costing not less than the amount equal to Rs.
 1,30,960/-each without tax OR
 - b) Two completed works each costing not less than the amount equal to Rs. 1,63,700/- each without tax OR
 - c) One completed work costing not less than the amount equal to **2,61,920/**-each without tax.

The tenderer shall furnish the documentary evidence to show that they have executed mentioned works successfully & satisfactorily. The tenderer should furnish the information as per Section –VII: Schedule C of the tender document. In support of this, the tenderer shall submit the order copy/copies in full along with relevant annexures/documents forming the part of the order or orders. In addition to this, the tenderer shall also enclose the copy/copies payment received towards the order placed to demonstrate completion of the order or orders under consideration or Certificate showing satisfactory completion of work. If order is executed for private Party TDS certificate is required for the same order.

ii. The Average Annual financial turnover of the tenderer during the last three years, ending 31st March 2020, should not be less than **Rs.** 98,220/- (Rupees Ninety Eight Thousand Two Hundred and Twenty only). The tenderer shall furnish necessary details as per Section-VII: Schedule B of the tender document. In support of this, the Tenderer should submit copies of audited P&L A/c statements and Balance sheets for last 03 Financial Years i.e. 2018-19, 2019-20 & 2020-21, duly certified by the Chartered Accountant (C.A.) clearly indicating Membership and registration number.

iii. Tenderer should have valid Electrical license issued by State Govt. Authority. The copy of the same shall be submitted in single cover Bid. In case the validity of license is expired recently (within 01month period before publish of subject tender) and it is under process of renewal, a proof to that effect shall be submitted with technical bid However renewed License copy shall be submitted with 15 days from the opening of technical bid otherwise the bid will be treated as disqualified and it will not be considered for further evaluation.

Tenderer shall furnish copies of Orders/ Work Orders, Delivery Challan and Invoice in support of execution of the order/work order along with details as per **Section-VII: Schedule-C** of this tender document.
