The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL Documents** of the tenderer found qualified by the 'Superintending Engineer, Western Electrical Circle, Public Works Directorate. The decision of the Superintending Engineer, Western Electrical Circle, Public Works Directorate will be final and absolute in this respect. The both list of Qualified Bidders will be displayed in the website and also in the Notice Board of the office of the Superintending Engineer, Western Electrical Circle, Public Works Directorate on the scheduled date and time.

5. **Eligibility criteria for participation in the tender.**

- i. The prospective bidders shall be the manufacturer of original product / authorised dealer and bonafide resourceful Electrical Contractor (Not a member of joint venture or sub-contractor) and intending bidder should have following credential criteria.
- (a) Intending tenderers should produce credentials of a similar nature (conforming to all major components of work as mentioned in the BOQ) of completed work, of the minimum value of 40 % of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice
- or
- (b) Intending tenderers should produce credentials of 2(two) similar nature (conforming to all major components of work as mentioned in the BOQ) of completed work, each of the minimum value of 30 % of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice
- or
- (c) Intending tenderers should produce credentials of one single running work of similar nature (conforming to all major components of work as mentioned in the BOQ) which has been completed to the extent of 80 % or more and value of which is not less than the desired value at (a) above

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executed agency i.e. the tenderer.
