paid final bill, Form 26AS and Form 16A of relevant period for verification of amount of work done.

- **4.** The amount of annual turnover as given in pre-qualification criteria shall be only for similar nature of works
- 5. Even though any tenderer may satisfy the above requirements, the tenderer would be liable to disqualification if tenderer has made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the eligibility criteria document etc.
- 6. The Bidder as joint venture is not eligible for Participation in Bidding.
