After hearing the parties, the Commission directed AHPCL to file the updated 'Tariff Forms' considering the impact/decision of the Order to be passed in the Review Petition(s) and change in law Petition in 'two weeks' time and serve a copy to UPPCL and UPPCL may file its reply in four weeks, thereafter.
