Upon receipt of the bids, the documents submitted by all the bidders shall be scrutinized with respect to submission of EMD as per NIT, other necessary documents, acceptance to all terms & conditions as per the tender. The offers shall be scrutinized only on the basis of the uploaded documents in e-tender portal. Price bids of only those parties who satisfy the above mentioned requirements will be opened.2. After opening of price bids, the tenderer with the lowest price (price bid BoQ basic cost after discount (-) or premium (+) or At Par over the estimate value + applicable GST) shall be considered as L1 bidder for the purpose of award of work with or without negotiations.3. In case of tie between two or more bidders due to identical rates received at L-1 position, then all the L-1 bidders shall be asked to submit discount bid in terms of percentage discount over previous quoted amount in a sealed envelope along with the turn over documents and also bidders shall be advised to witness the opening of sealed envelopes.4. In case there is a tie again due to identical discount bids, the bidder with the highest annual turnover worked out to three decimal points in any of the last three years (FY 2019-20, 2020-21 & 2021-22) as submitted against Turnover documents in sealed envelope shall be considered as L1 bidder. In the event of bidder submitting turnover documents for only one or two years, L1 shall be decided on the basis of turnovers submitted.5. For the purpose of highest annual Turnover, the audited balance sheet/profit and loss statements of the last three Financial Years (FY 2019-20, 2020-21 & 2021-22) shall be considered.
