#### 1. INTRODUCTION

The following words and expressions shall have the meanings hereby assigned to them:

**"Applicable Law"** means any statute, law, regulation, ordinance, notification, rule, regulation, judgment, order, decree, bye-law, approval, directive, guideline, policy, requirement or other governmental restriction or any similar form of decision of, or determination by, or any interpretation or administration having the force of law in the Republic of India and the State Government, by any Government Authority or instrumentality thereof, whether in effect as of the date of this Contractor thereafter.

**"Bid"** shall mean the bid submitted by the Bidder in response to the Tender No "TN-22/2021-22" issued by RRVUNL.

**"Bidder"** shall mean Bidding Company or a Bidding Individual submitting the Bid. Any reference to the Bidder includes Bidding Company/ Bidding Individual including its successors, executors and permitted assigns severally, as the context may require;

**"Completion"** means that the entire works have been completed as per the Scope of Work.

**"Consultant"** shall mean Successful Bidder appointed to carry out work as per scope of works defined in this Tender and mutually agreed by both parties.

**"Consultant's Equipment"** means all plant, facilities, equipment, machinery, tools, apparatus, appliances or things of every kind required in or for execution of work that are to be provided by the Consultant.
