# Section 3: Instructions for filling Application Form for Prequalification

- 1. The Application shall be submitted by the applicant on their letterhead in the prescribed format as per Form I along with prequalification document and other enclosures, if any.
- 2. The Application shall be submitted in the specified format only. No page or content of the Prequalification Document shall be edited/ tampered/ removed. In case, any such alteration is found at any stage, the application is liable to be rejected.
- 3. Each page of the Prequalification Document and the enclosures shall be duly signed and stamped by the applicant. The prequalification document shall be signed by person/s on behalf of the organization having necessary authorization/ Power of Attorney to do so.
- 4. Intending applicants are required to submit their full bio-data giving details about their organization, experience, competence and adequate evidence of their financial standing, etc., in the enclosed Form II along with requisite testimonials. Incomplete applications or applications without proper proofs for establishing their credentials may not be considered.
- 5. While filling up the application form with regard to the list of important works carried out or in hand (Form III, IV and V), the applicants shall include only those similar works which individually cost not less than Rs.31 Lakh. If the space in Form III, IV and V is insufficient for furnishing full details, the information shall be supplemented in separate sheets of paper stating therein the part of the statement and serial number and should be duly signed and sealed. Separate sheets shall be used for each part.
- 6. Applications containing false and/ or inadequate information are liable for rejection. Applicants shall be disqualified at any stage at their risk and cost if they are found to have "Made untrue or false representation in the forms, statements and attachments submitted in proof of qualification and requirements".
- 7. The intending applicants are advised to enclose photocopies of all relevant documents as mentioned in the list of testimonials and other required documents wherever required.
- 8. Decision of the Board with regard to prequalification of Agency for issue of tender documents will be final. SEBI reserves the right to shortlist the agencies by relaxing the set criteria or inclusion of other criteria should a condition warrant. The Board also reserves the right to restrict number of applicants for tendering at its sole discretion. SEBI is not bound to assign any reason thereof. The empaneled agencies will only be informed.
- 9. SEBI reserves the right to reject any or all the applications without assigning any reason whatsoever. SEBI also reserves the right to restrict number of applicants for prequalification/ tendering at its sole discretion. SEBI's decision in this regard shall be binding on all concerned.



- 10. The applicant shall not be entitled to claim any cost, charges or incidentals for or in connection with the preparation and submission of the tenders.
- 11. If the application is made by a partnership firm, a certified copy of the partnership deed, current address of the firm and the full names and current addresses of all the partners of the firm shall also accompany the application. If the application is made by a limited company it shall be signed by a duly authorized person holding the power of attorney for signing the application in which case certified copies of the power of attorney and the certification of incorporation, Memorandum of Articles of Association shall accompany the application.
- 12. If information and details furnished by applicants are found to be false/ inadequate at any time in future or any information withheld which comes to the notice of SEBI at a later date, SEBI may take necessary and appropriate action as may be deemed fit.
