- 1. Bidders not registered with Government of Odisha, should be registered under Odisha Government before the award of contract failing which the bid security shall be forfeited.
- The Bid documents will be available in the website: <u>https://tendersodisha.gov.in</u> from 02.11.22 at 10.30 Hours. Any addendum / corrigendum / cancellation of tender can only be seen in the said website.
- 3. Bids shall be received only "On line" on or before 19.11.22 up to 17.00 Hours. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- 4. Bids received on line shall be opened at 11.30 Hours on ) 2 11.22 in the office of Executive Engineer, Division-IV, BDA, Bhubaneswar in the presence of the bidders who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 5. Validity of Tender: Validity of tender shall be for a period of **90 days** from the date of opening of the tender (Financial bid).
- 6. Bids must be accompanied by scanned copies of Registration Certificate, Bid Security declaration and required affidavit in the prescribed form appended in DTCN indicating name of the work and

Bid submitted without the above documents in the prescribed format will be rejected.

- 7. After the date & time of receipt of bid is over, the bidders must submit the original Demand draft towards cost of Bid documents and original Bid security in the office of the Executive Engineer, Division-IV, BDA, Bhubaneswar in a sealed envelopes to be received on or before 10.30 AM on [8.11.22] by speed post or registered post on working days failing which the bid will be rejected. Only envelopes containing these documents shall be opened on the date of opening prior to opening of the Technical bid for evaluation. The Authority is not responsible for any postal delay in receipt of these documents within stipulated date and time. If the last date of receipt of the sealed envelope falls on a holiday, then the same can be received on the next working day.
- 8. Other details can be seen in the bidding documents.
- 9. The authority reserves the right to cancel any or all bids without assigning any reason.
- 10. The ST/SC contractors willing to avail the facilities as fixed by Government shall have to upload scanned copy of the affidavit for the same along with tender document and the original affidavit along with original RC book, otherwise they will not be entitled to avail such facilities.
- 11. Additional Performance Security shall be deposited by the successful bidder before execution of agreement when the bid amount is less than the estimated cost put to tender. The Additional Performance Security in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Executive Engineer, Division-IV, BDA, Bhubaneswar and payable at Bhubaneswar, before execution of agreement failing which bid will be cancelled with forfeiture of EMD. The Additional Performance Security will be over and above the performance security. The additional performance security in any other form will not be accepted. If the Contractor fails to complete the work, the amount so furnished as additional performance security will be forfeited in addition to the other penalty, if any to be imposed.
