

For and on behalf of the President of India, the Director, Directorate of Lighthouses and Lightships (DLL), Port Blair, invites online bids under two cover system (Part I-Technical Bid, Part II Commercial Bid) from reputed contractors, shall having experience and expertise for the following work by 15.12.2022 at 1500Hrs.

3	Period of Contract	Initially for a period of 01 year and shall be extended for further 02 years on yearly basis subject to satisfactory performance
4	Earnest Money Deposit	Rs.12,320/- (Rupees Twelve Thousand Three Hundred and Twenty Only) in the form of Demand Draft/Fixed Deposit receipt (FDR) of any scheduled Nationalized Bank drawn in favor of Director of Lighthouses and Lightships, Port Blair payable at Port Blair. EMD shall be valid for a period of 06 months from the date of opening of technical bid.

- 1.1 The details of work are available in the tender document which can be downloaded from Central Public Supply, Installation, Testing and Commissioning (CPP) Portal http://eprocure.gov.in/eprocure/app and the bid is to be submitted online only on http://eprocure.gov.in/eprocure/app up to last date and time of submission of tender. Sale of physical tender document is not applicable. Those bidders having valid registration in NSIC/MSME shall be considered or exemption, in submission of EMD/Tender fee/ past experience/turnover as per prevailing Govt. norms.
- 1.2 The Technical Bids will be scrutinized by a Tender Evaluation Committee appointed by the Director of Lighthouses and Lightships (DLL). The bids, which do not meet the tender requirements, are liable to be rejected. The commercial bids of technically qualified bidders meeting with the pre-qualification requirements shall only be opened. The decision of the Director of Lighthouses & Lightships, Port Blair in deciding the successful bidder shall be final and binding on the bidders.
- 1.3 The date of technical bid opening is subject to the availability of internet connectivity. Hence, the technical bid opening date is under the jurisdiction of the Director.
- 1.4 The Bidder shall carefully read Eligibility Criteria & instructions to Bidders, Technical requirement & Scope of work, General& Special conditions of contract, and all other documents in connection with the Bid. The Bidder shall quote his rates, keeping all above points in mind.
- 1.5 The bid comprises of Supply, Installation, Testing and Commissioning of Invertor for Solar Power Plant at North point Light House Port Blair .. Director, Directorate of Lighthouses & Lightships, Port Blair reserves to himself the right of accepting/rejecting the bid. Bidder shall be bound to perform the same at the quoted rates.
- 1.6 Canvassing whether directly or indirectly, in connection with Bid is strictly prohibited. The Bids submitted by the Bidders, who resort to canvassing, shall be summarily rejected.
- 1.7 Those Bidders whose near relatives are posted as accountant or as a gazetted Officer in any capacity in the Directorate of Lighthouses & Lightships Port Blair shall not be permitted to Bid. The prospective Bidder shall also intimate the names of persons who are working in the office of Director of Lighthouses and Lightships, Port Blair in any capacity or subsequently employed, who are near relative to any gazetted officer in the DGLL or in the Ministry of Ports Shipping& waterways. Any breach of this condition by the bidder shall render him ineligible. By the term 'near relative' is meant wife, husband, parents & grand parents, children & grandchildren, brothers & sisters, uncles, aunts & corresponding in laws.
- 1.8 No Gazetted Officer of Government of India is allowed to work as a contractor without prior permission of the Govt. of India in writing for a period of two years after his retirement from government service. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of Govt. of India as aforesaid, before submission of the Bid or engagement in the contractor's service.
- 1.9 In the event of any specific date, being or declared as a holiday by the Government of India, the specified activities shall take place on or up to the appointed time on the next working day.

1.10 The Notice Inviting Bids, all types of corrigendum/addendum/terms and condition of tender etc. shall form the part of contract document.
