**All the Tender documents are to be submitted online only and in the designated covers on the above website and no manual submission will be entertained.** The pre-qualification/technical bid shall be opened online at the office of the Chief Engineer (Renewable Energy & Energy Savings), 9<sup>th</sup> Floor, Vydyuthi Bhavanam, Pattom, Thiruvananthapuram on the date and time mentioned above in the presence of the bidders/ their representatives who wish to attend. All other existing conditions related to the tenders of KSEBL will be applicable to this tender also.
