ORDER

(Date of hearing: 19.01.2023)

1. Sh. Sudarshan, Senior General Manager appeared on behalf of Powergrid Gomti Yamuna Transmission Limited submitted that Petitioner has filed the instant petition under Section 63 of the Electricity Act, 2003 (the Act) for adoption of transmission tariff with respect to the transmission system being established by the Petitioner. He submitted that the Commission may take affidavit dated 29.12.2022 in regard to SCOD on record.
2. On the query of the Commission regarding submission of certificate by Bid Evaluation Committee, Sh. Dheeraj Kumar, Executive Associate, PFCCL informed that the certificate by Bid Evaluation Committee has been filed vide its submission dated 09.11.2022 before the Commission.
3. The Commission noted that the Transmission License was granted to the Petitioner vide Commission's Order dated 20.12.2022, after holding public hearing and following due process in accordance with the Act. Further, the Commission observed that since Respondent No. 1 to 5 (Long Term Transmission Customers) were not present during the hearing, therefore in order to meet the ends of justice it was decided to grant final opportunity to these Respondents to appear before the Commission in next hearing and thereafter the Commission shall decide the case as considered deemed fit on the basis of information available on record. The Commission also directed Petitioner to serve the copy of Petition to U.P. Power Corporation Limited (in capacity of holding company of state owned distribution licensees), who may also appear before the Commission on next date of hearing with its response.
4. The matter is next listed for hearing on 27th January 2023.
