- 2.0 After login to Contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT & download copy of the tender. The tender can be downloaded from the portal as per prescribed date & time published in the portal. Only interested bidders who wish to participate should remit online transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

3.0 SCOPE OF WORK

"Supply, Installation, Testing & commissioning of 110V, 100AH, Battery Bank - 55 cells (1 set) at 10MW Shivasamudra Solar PV Plant Mandya Dist." along with all other associated works as per IS/IEC and KPTCL Technical Specifications

- **4.0 AMOUNT PUT TO TENDER:** Rs. 3,15,200/-
- **5.0** Bids can be uploaded on to e-procurement platform before the date and time notified for uploading the Bids in e-procurement platform.
- 6.0 The Techno- Commercial Bids will be opened on the date and time notified for opening of the Techno Commercial bids in e-procurement platform. The Price Bids of those Bidders whose Techno-Commercial Bids are found Responsive will be opened at a later date under intimation to the Qualified Bidders, either by regular Mail or by e-mail.

7.0 EARNEST MONEY DEPOSIT (EMD)

Bids shall be accompanied by Tender Processing Fee, for an amount as mentioned in the e-Procurement platform and Bid Security (EMD) for an amount of Rs. 8,000/- as follows; The Payment of the same shall be made through any of the following modes of e-Payment.

- Credit Card/Debit Card.
- Net Banking.
- NEFT/RTGS/IMPS
- Over-the-Counter (OTC).

NOTE: EMD payment at e-procurement portal is through ICICI Bank. For further clarification, contact e-procurement portal.

- 8.0 Tenders (both Cover-I & II) must be electronically submitted (online through internet) within the date & time published in e-procurement portal. Cover-I of Tender will be opened at prescribed time & date in the e-procurement portal, in presence of the Tenderers who wish to attend at the office of the Chief Engineer(O&M)YCPPP, Bengaluru. Opening of Cover-II shall be intimated later.

11.0 ELIGIBILITY CRITERIA:

The minimum essential Qualifying Requirements are as under:

i. The bidder shall be a Proprietorship firm or Partnership firm or company incorporated under Companies Act, 1956/2013.

- ii. The Bidder must Comply with all statutory obligations. Valid company Registration Certificates including GST, PF, ESI.
- iii. Bidder should have successfully carried out similar type of work in any power projects/ sub stations/Industries. Same shall be in satisfactory operation continuously for a minimum period of 1 year during the preceding 5 years, from the date of issue of NIT with total Order value not less than Rs. 1.60Lakhs. Satisfactory performance certificate issued from Competent Authority/State /Central Government undertaking/any utility from officers not below the rank of Executive Engineer/ equivalent cadre/ Project head of respective plants / Industries shall be furnished. The copy of the work order and work done for corresponding works shall be furnished.
- iv. Bidder during the last five financial year period shall have achieved average turnover of Rs. 6.30Lakhs for atleast two financial years. Annual report, turn over certificate, copy of Auditor's Report along with the Balance Sheets, Profit & Loss statements and other financial statements shall be uploaded as a documentary proof duly certified by charted accountant.
- v. The declarations as mentioned in the tender document shall be uploaded.

12.0 General:

- a) The bidder should not have been disqualified for non-performance in any of the Government utilities in the past five years and bidder shall furnish a selfdeclaration to this effect.
- b) Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any State Government / Government of India /Union Territory.
- c) It shall be the responsibility of the Bidder to ensure credit of Tender Processing Fee into the respective receiving bank accounts of e-Procurement on or before the last date and time of bid submission.
- d) The bidder is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches at bidder's end.
- e) The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- f) Rates shall be quoted in Price Schedule (Financial bid) in the website itself and not upload the same in Technical bid, failing which Tender will be rejected.
- g) The tender shall be valid for 180 days from the date of opening of the Technical bid (Cover I).
- h) The tender document is part and parcel of the agreement.
- i) Conditional tenders are liable for rejection.

- j) The successful bidder shall give an undertaking that they would abide by the provisions of the Employees Provident Fund Act. The bidder shall quote his rates inclusive of PF as per the applicable rate as issued by the PF department from time to time.
- k) The bidder shall obtain insurance coverage for all the workers deployed for this work.
- 1) The bidder shall quote his rates inclusive of all applicable taxes, levies, duties, etc., as per the latest GoK and GoI prevailing as on the date of opening of technical bid (Cover-I).
- m) KGPCL shall recover the Income Tax, building workers welfare cess, etc., at the prevailing applicable rates.
- n) The bidder should maintain register of workers deployed and wages paid for the workers and shall produce the documents whenever called for by the competent authority. Remittance towards PF shall be commensurate with the labour component of the work involved.
- o) Bidder should have independent PF code. The bidder shall remit PF of labourers to Contractor's permanent PF code number only.
- p) In case the dates notified above are declared as holiday, the immediate next working day will be reckoned.
- q) If the Bidder makes any alterations in the conditions of the contract or puts any condition of his own, such tenders are liable for rejection.
- r) Corrigendum / modification / corrections, if any, will be published in the web site only.
