SCHEDULE 1 - Rs 44,50,000 (Rs Forty Four Lakhs Fifty Thousand Only)

SCHEDULE 2 - Rs 41,00,000 (Rs Forty One Lakhs Only)

If any bidder wants to quote for more than one schedule, then the EMD for those schedules as shown above should be added up and submitted.

- 1(c). EMD submitted in the form of Bank Guarantee shall be issued by any scheduled bank (other than cooperative bank). - 1(d). Bank guarantee in any other format other than that provided in the tender document shall be treated as offer without EMD and such offer shall not be acceptable.
- 1(f). Bidders who wish to submit bank guarantee (BG) towards EMD/Composite Performance Bank Guarantee (CPBG)/Advances/ towards any other requirement of the tender, is required to ensure that

### **EXEMPTION FROM EMD:**
